WENTWORTH IRRIGATION (AMENDMENT) BILL 1986

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Water Administration Bill 1986.

The object of this Bill is to amend the Wentworth Irrigation Act 1890-

- (a) as a consequence of the constitution by the proposed Water Administration Act 1986 of the Water Administration Ministerial Corporation ("the Ministerial Corporation") and its replacement of the Water Resources Commission;
- (b) to make further provision with respect to water rates and charges; and
- (c) to increase penalties.

Clause 1 specifies the short title to the proposed Act.

Clause 2 provides that, with minor exceptions, the proposed Act will commence at the same time as the proposed Water Administration Act 1986.

Clause 3 is a formal provision that gives effect to the amendments specified in Schedules 1 and 2.

Clause 4 provides for the transition to the Ministerial Corporation of responsibility for past actions under the Wentworth Irrigation Act 1890 of its predecessor and the Minister that still had effect immediately before the commencement of the proposed Act.

Schedule 1, items (11) (c) and (12) (e) excepted, amends the Wentworth Irrigation Act 1890 in a manner consequential upon the enactment of the proposed Water Administration Act 1986.

Schedule 1 (11) (e) provides for amounts of unpaid rates, charges and interest to be a charge on the relevant land and recoverable as a debt.

⁵ Schedule 1 (12) (e) enables by-laws to be made in relation to the charging of interest, and the discontinuance of water supply if an amount of rates, charges or interest is unpaid.

Schedule 2 increases penalties.



A BILL FOR

An Act to amend the Wentworth Irrigation Act 1890 as a consequence of the enactment of the Water Administration Act 1986; to make further provision with respect to rates and charges, and to increase penalties, under the Wentworth Irrigation Act 1890; and for other purposes.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:

5 Short title

1. This Act may be cited as the "Wentworth Irrigation (Amendment) Act 1986".

Commencement

2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.

(2) Except as provided by subsection (1), this Act shall commence on the commencement of the Water Administration Act 1986.

3. The Wentworth Irrigation Act 1890 is amended in the manner set 15 forth in Schedules 1 and 2.

Saving

4. If anything done under the Wentworth Irrigation Act 1890 before the commencement of this Act by the Minister or a predecessor of the Water Administration Ministerial Corporation—


