WORKERS' COMPENSATION (SENIOR POLICE) AMENDMENT BILL, 1984

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Police Regulation (Promotions) Amendment Bill, 1984.

The object of this Bill is to amend the Workers' Compensation Act, 1926, to bring within the provisions of that Act any person who is appointed from outside the police force to the office of Commissioner, Deputy Commissioner or Assistant Commissioner and who elects not to contribute to the Police Superannuation Fund under the Police Regulation (Superannuation Act, 1906, which provides "hurt on duty" benefits.

Workers' Compensation (Senior Police) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

5 Short title.

1. This Act may be cited as the "Workers' Compensation (Senior Police) Amendment Act, 1984".

Commencement.

2. (1) Sections 1 and 2 shall commence on the date of assent to this 10 Act.

(2) Except as provided by subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Police Regulation (Promotions) Amendment Act, 1984.

3. The Workers' Compensation Act, 1926, is amended by inserting in paragraph (c) o fthe definition of "Worker" in section 6 (1) after the word "force" the words ", not being a member of the police force who has made the election referred to in section 1B of the Police Regulation (Superannuation) Act, 1906".
