EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Exhibited Animals Protection Bill 1986.

The object of this Bill is to amend the Zoological Parks Board Act 1973 to enable the Zoological Parks Board—

- (a) to exercise the functions conferred or imposed on it by or under the proposed Exhibited Animals Protection Act 1986; and
- (b) to arrange for the use of the services of certain persons to assist in the exercise of those functions.

Clause 1 specifies the short title of the proposed Act.

Clause 2 is a formal provision which gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 (1) (a) amends section 13 of the Principal Act to enable the Board to arrange for the use of the services of officers or employees of a Government department or public authority constituted under an Act for the purpose of exercising or performing its powers, authorities, duties and functions under an Act other than the Principal Act.

Schedule 1 (1) (b) makes an amendment by way of statute law revision.

Schedule 1 (2) amends section 15 of the Principal Act to provide that the Board may exercise and perform powers, authorities, duties and functions conferred or imposed on the Board by or under an Act other than the Principal Act.


