

An Act to repeal the Book Purchasers' Protection Act 1899; and for associated purposes. [Assented to 15 November 1988]

Book Purchasers' Protection (Repeal) 1988

#### The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Book Purchasers' Protection (Repeal) Act 1988.

#### Repeal of Book Purchasers' Protection Act 1899 No. 25

2. The Book Purchasers' Protection Act 1899 is repealed.

#### **Repeal of Book Purchasers' Protection Regulation 1964**

3. The Book Purchasers' Protection Regulation 1964 is repealed.

#### Savings

4. (1) The repeals effected by this Act do not affect any contracts entered into before the commencement of this Act.

(2) This section shall not be construed as limiting the operation of section 30 of the Interpretation Act 1987.

#### (This Explanatory Note relates to this Bill as introduced into Parliament)


The object of this Bill is to repeal the Book Purchasers' Protection Act 1899.

Clause 1 specifies the short title of the proposed Act.

Clause 2 repeals the Book Purchasers' Protection Act 1899.

Clause 3 repeals the Book Purchasers' Protection Regulation 1964.

**Clause 4** provides that the repeal of the Act and Regulation does not affect any contracts entered into before the commencement of the proposed Act.
