

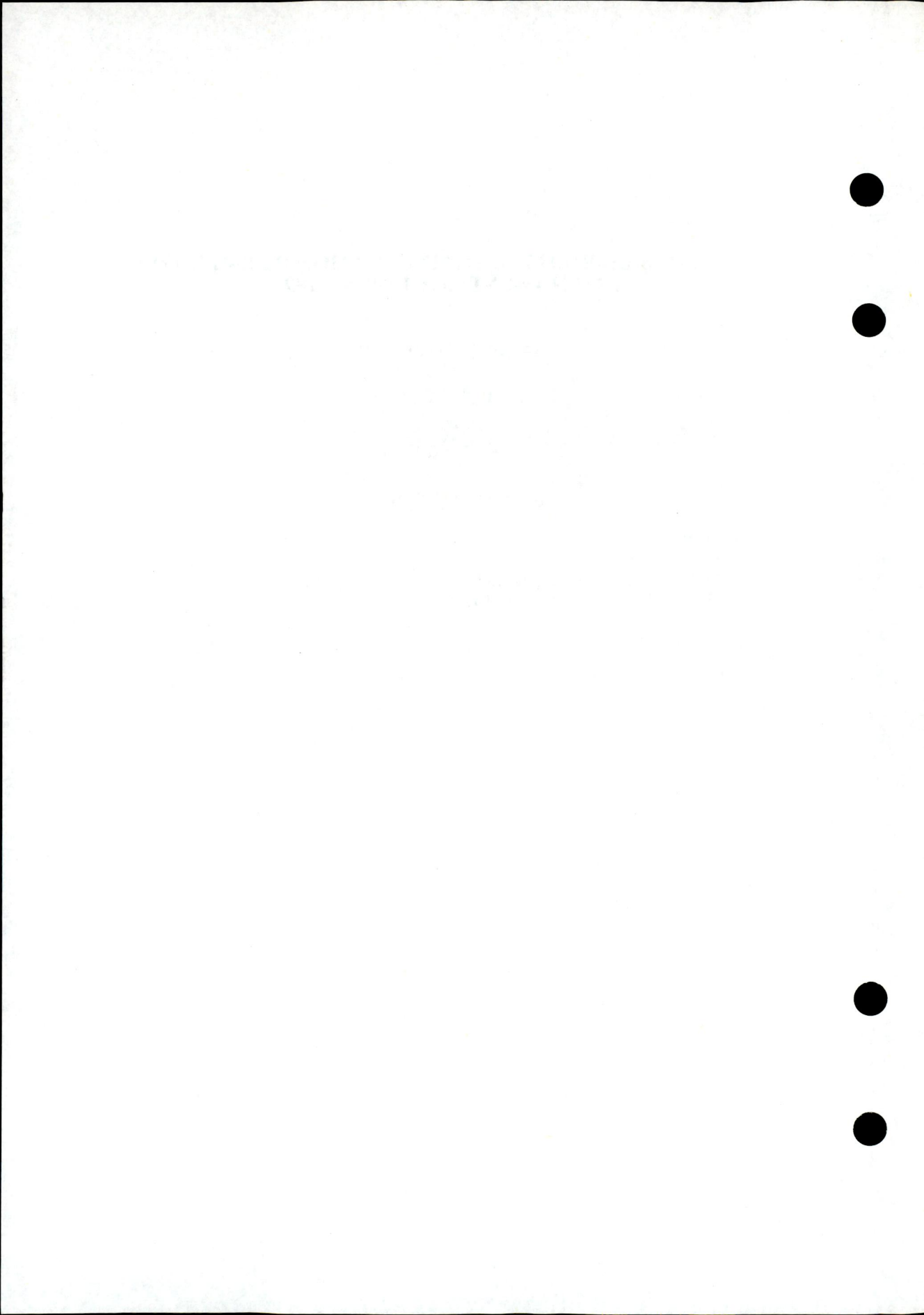

**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Law Reform (Vicarious Liability) Amendment Bill 1989.

The object of this Bill is to amend the Employee's Liability (Indemnification of Employer) Act 1982 to make it clear that the Act applies to employees of the Crown in the same way as it applies to other employees. As a result, employees of the Crown will not be liable to indemnify the Crown in respect of actions in tort against the Crown resulting from the employees' negligence at work.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act is to commence on assent.

Clause 3 makes the amendment referred to above.

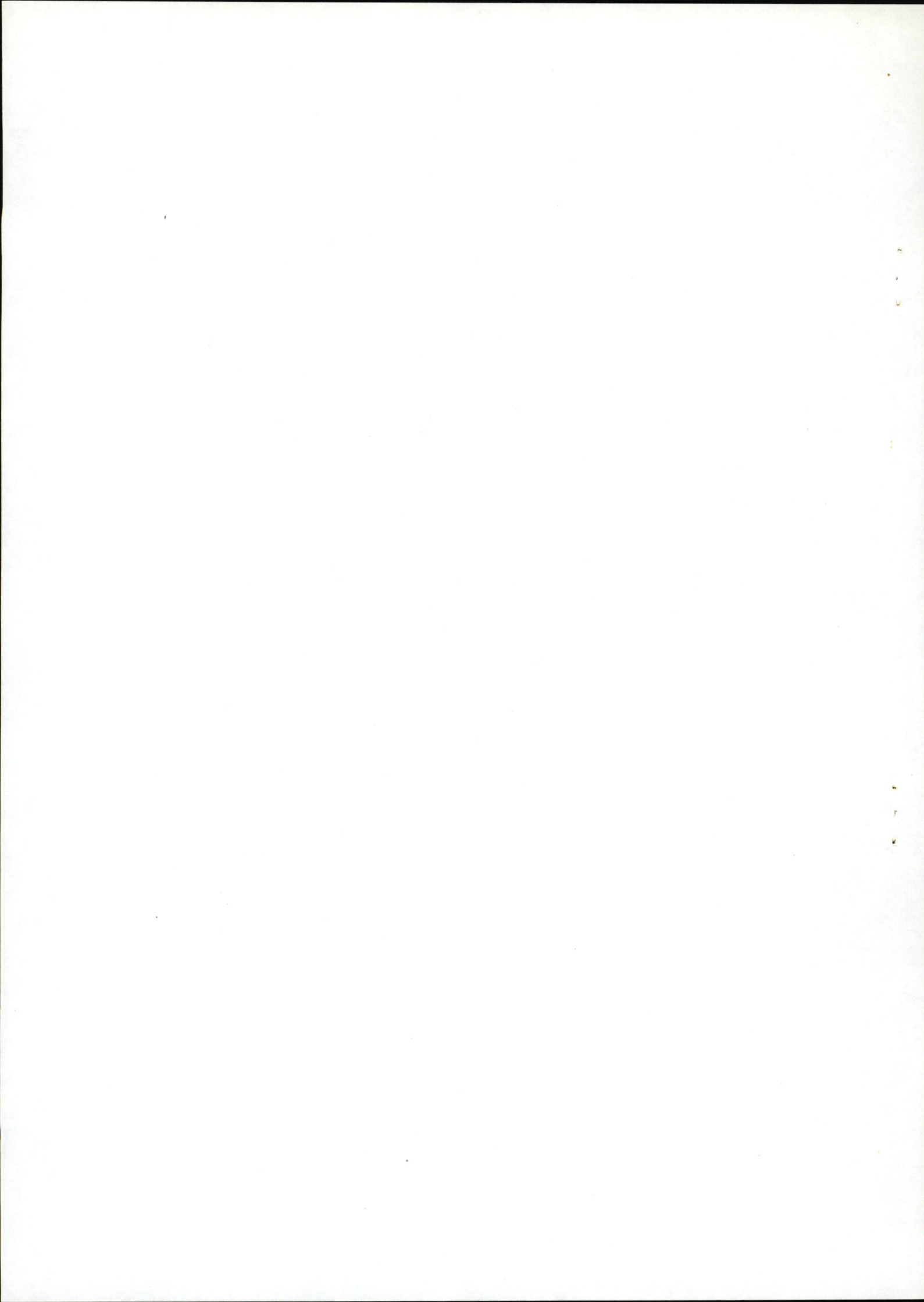
