**FAMILY PROVISION (FOREIGN LAND) AMENDMENT BILL

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Jurisdiction of Courts (Foreign Land) Bill 1989.

The object of this Bill is to amend the Family Provision Act 1982 so as to provide that an order for provision out of the estate or notional estate of a deceased person may be made in respect of property which is situated in or outside New South Wales.

Clause 1 specifies the short title of the proposed Act.

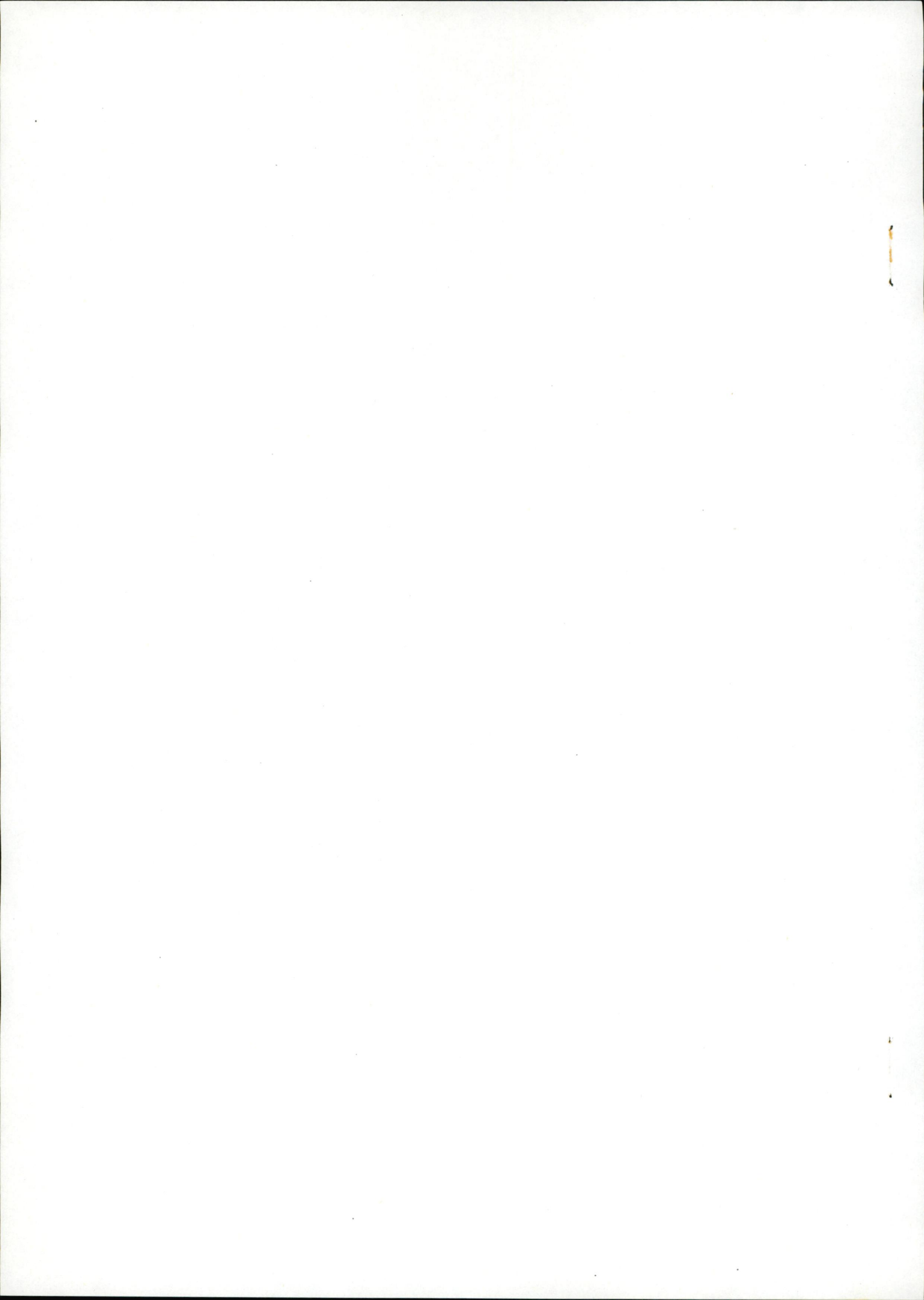
Clause 2 provides for the proposed Act to commence at the commencement of the proposed Jurisdiction of Courts (Foreign Land) Act 1989.

Clause 3 is a formal provision that gives effect to the Schedule of amendments.

Clause 4 provides that the proposed Act applies in relation to a deceased person dying before or after the commencement of the Act.

SCHEDULE 1 - AMENDMENTS

Schedule 1 amends section 11, firstly, by providing that orders for provision may be made in respect of property which is situated in or outside New South Wales and, secondly, by omitting section 11 (2) which becomes superfluous by reason of the first amendment.

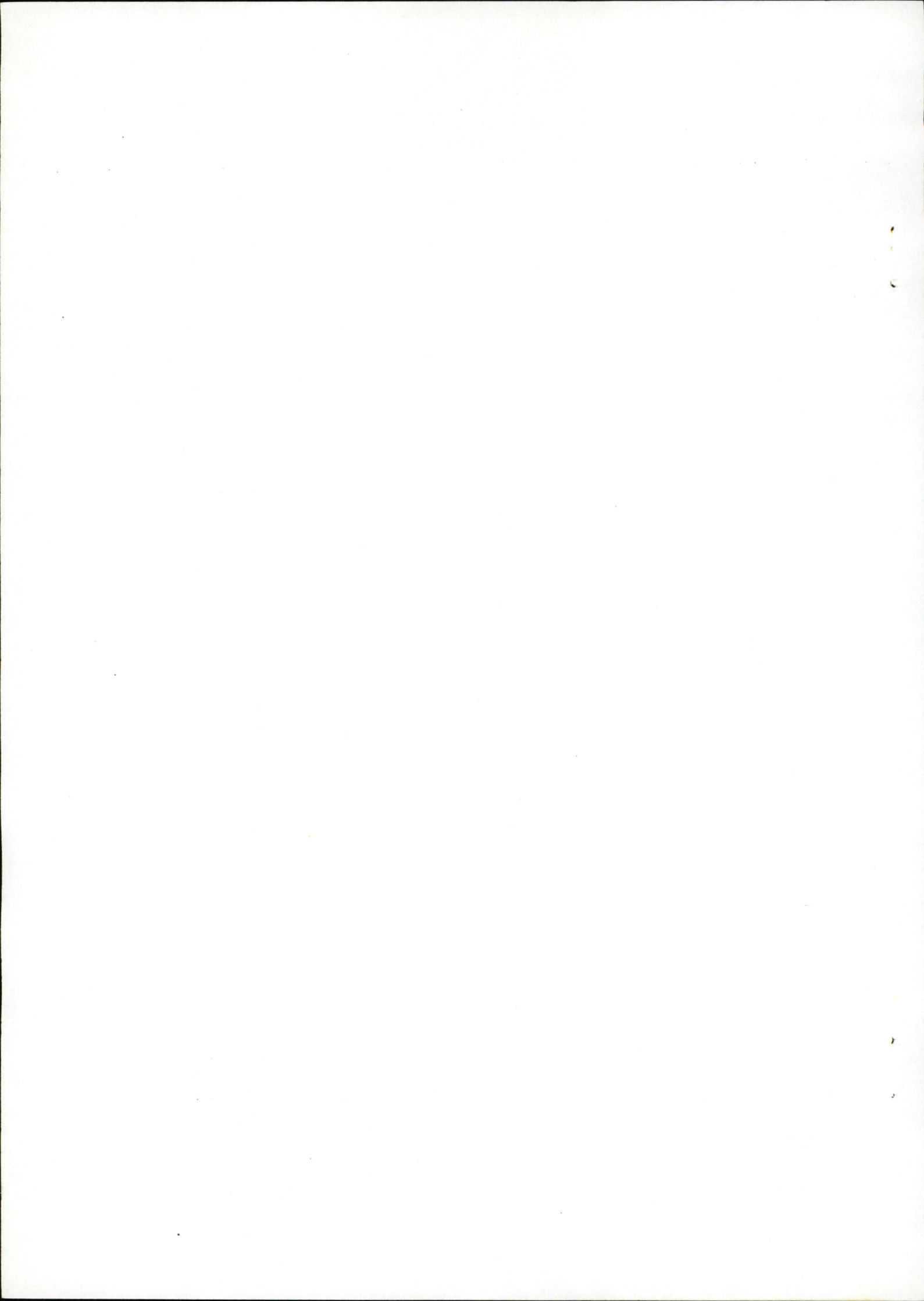

Family Provision (Foreign Land) Amendment 1989

The Legislature of New South Wales enacts:

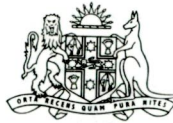
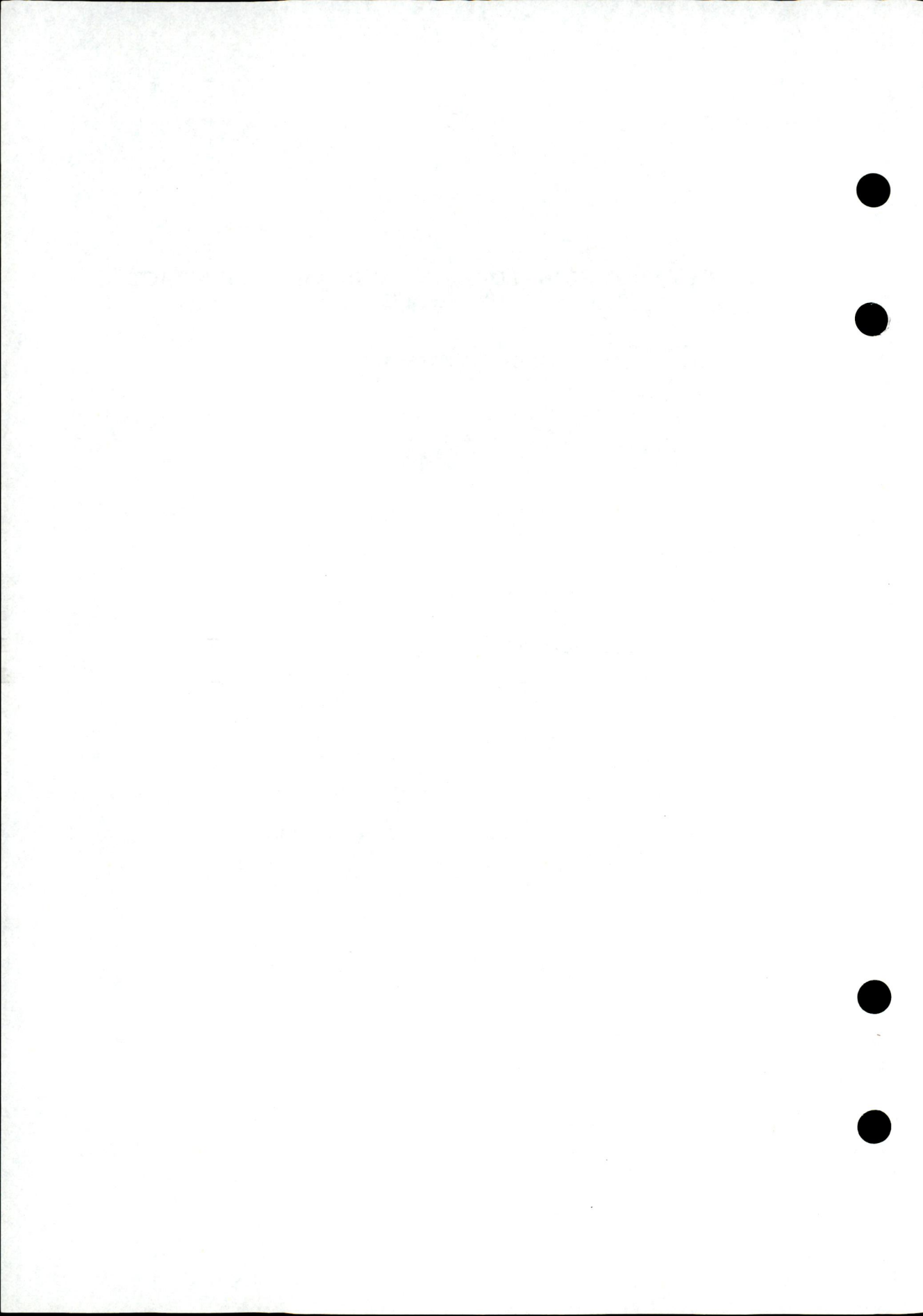

The Legislature of New South Wales enacts:

Short title

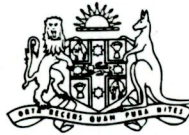
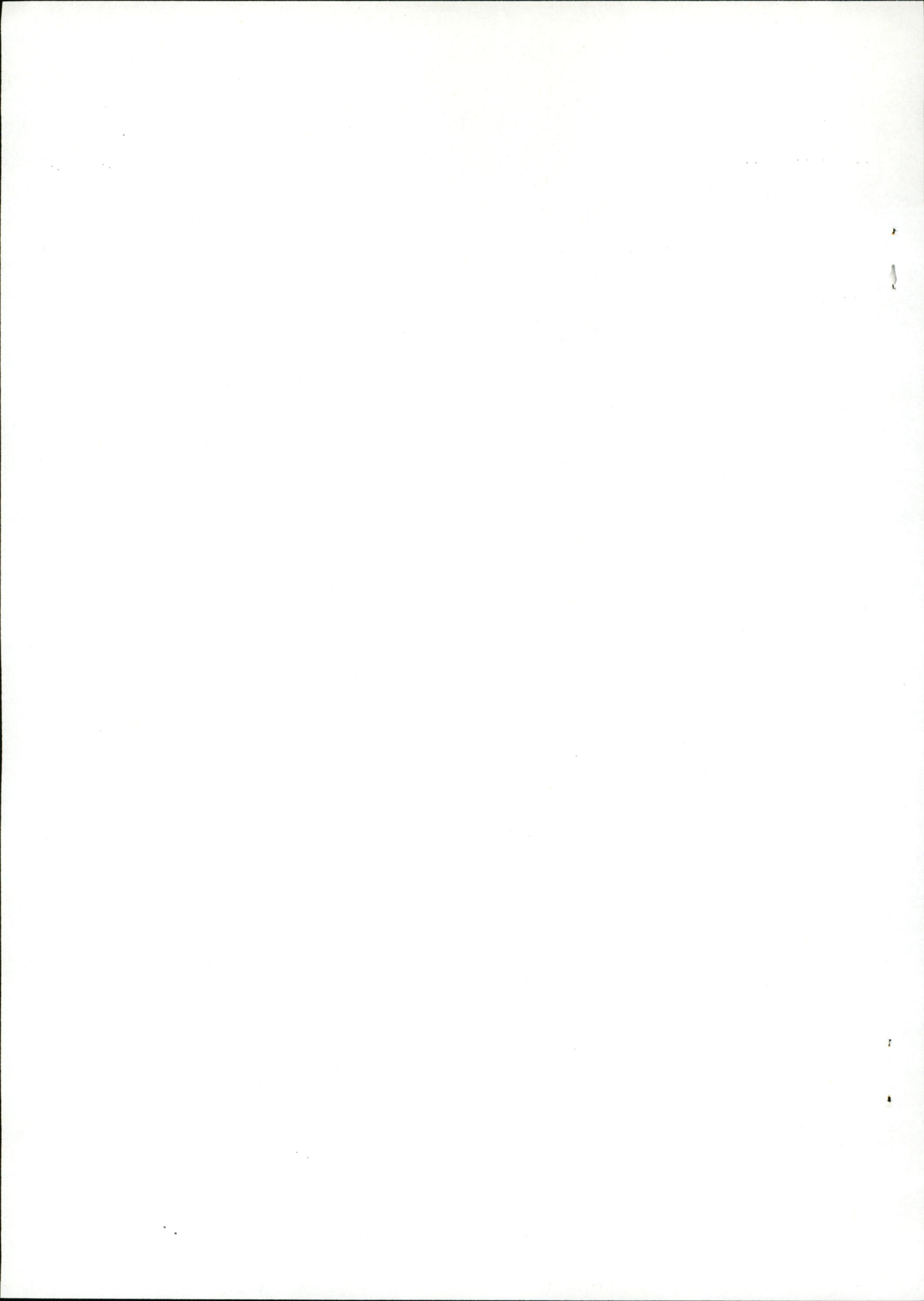
