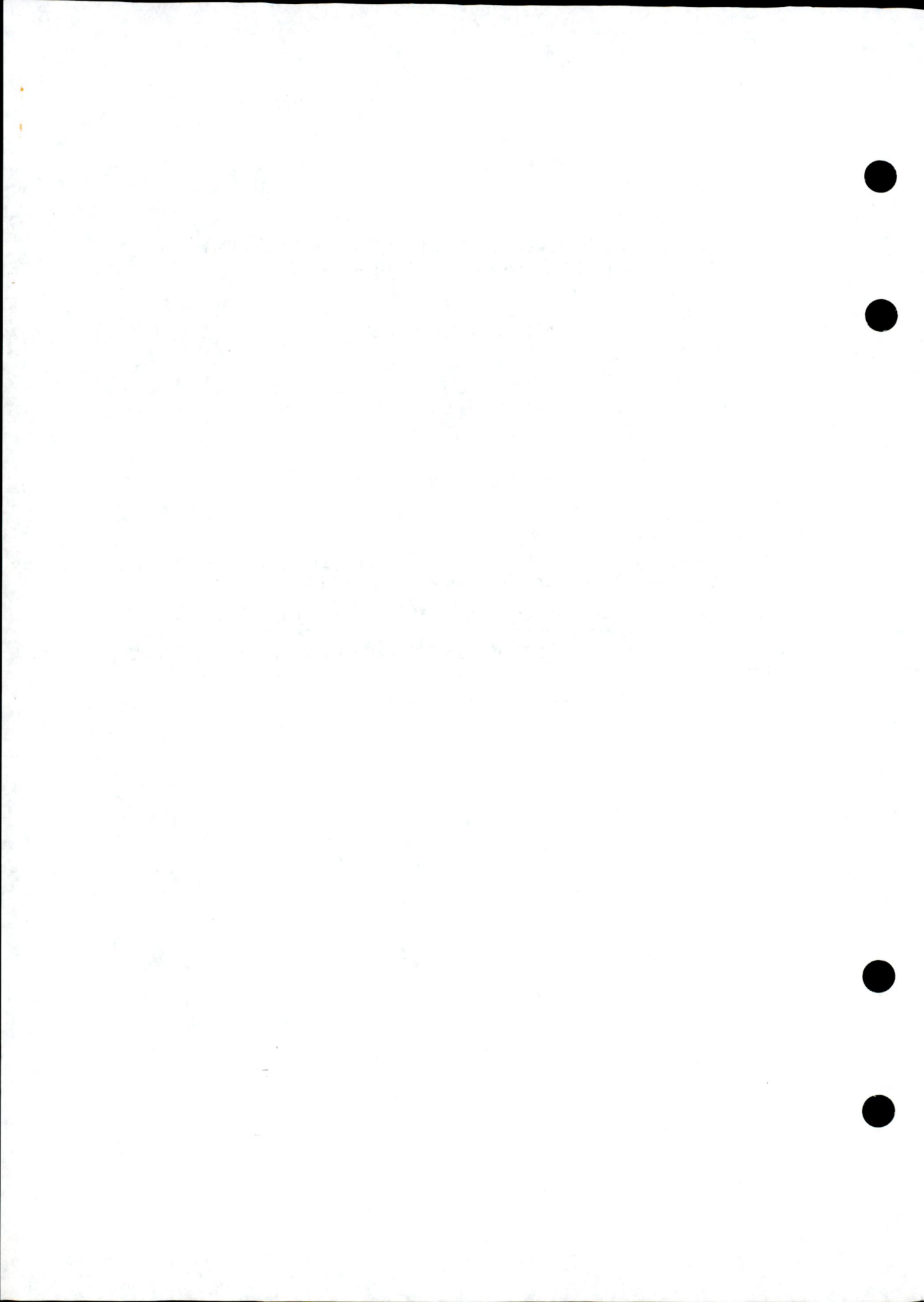

Act No. 12, 1990

An Act to amend the Health Administration Act 1982 and certain other Acts relating to health professional boards with respect to the employment of staff and the keeping of accounts; and for other purposes. [Assented to 7 June 1990]

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Health Professional Boards Legislation (Amendment) Act 1990.

Commencement

2. This Act commences on a day or days to be appointed by proclamation.

Amendment of certain Acts relating to health professional boards

3. Each Act specified in Schedule 1 is amended as set out in that Schedule.

(2) The Board is to pay into the Account, from practising fees payable under this Act by registered nurses, enrolled nurses and enrolled nurses (mothercraft), such amounts as are determined by the Minister from time to time.

(3) The Minister may not determine an amount under this section without first consulting with the Board.

(4) Money in the Account may be expended by the Board for or towards any one or more of the following:

- (a) education (including post graduate education) and research in nursing;
- (b) any public purpose connected with the profession of nursing;
- (c) meeting administrative expenditure incurred with respect to the Account and the purposes for which it is used,

or any related purpose.

(5) Any expenditure of money under this section must not be made unless it is authorised by a resolution supported by at least 7 members of the Board at a meeting

- (a) in the manner authorised by the Public Authorities (Financial Arrangements) Act 1987; or
- (b) if that Act does not confer power on the Corporation to invest the money, in any other manner approved by the Treasurer.

(5) The interest or profits accruing from any such investment are to be paid into the relevant account.

(2) Section 14 (**Employees of Corporation**):

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill applies to the following health professional boards:

- * Chiropractors Registration Board
- * Chiropractors Registration Board
- * Dental Technicians Registration Board
- * Nurses Registration Board
- * Optical Dispensers Licensing Board
- * Board of Optometrical Registration
- * Physiotherapists Registration Board
- * Podiatrists Registration Board
- * Psychologists Registration Board

The objects of this Bill are:

- * to enable a board to which this Bill applies to operate as a self-funding body by providing for fees which it collects to be transmitted to the Health Administration Corporation to be paid into a separate Special Deposits Account in the Treasury. The money in the Account for the board is to be used by the Corporation to pay the board's administrative costs (including staff).
 - * to provide for the Corporation to employ the staff required to enable the boards to exercise their functions. (Currently, the staff are public servants.)
 - * to amend the Nurses Registration Act 1953 to enable the Minister, in consultation with the Nurses Registration Board, to determine the amount of the practising fees paid under that Act which are to be paid into the Nurses Registration Board Education and Research Account. (Currently the Act provides that 50 per cent of all practising fees paid under the Act must be paid into that Account.)

Health Professional Boards Legislation (Amendment) 1990

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on a day or days to be appointed by proclamation.

Clause 3 gives effect to Schedule 1 which contains amendments to the following Acts:

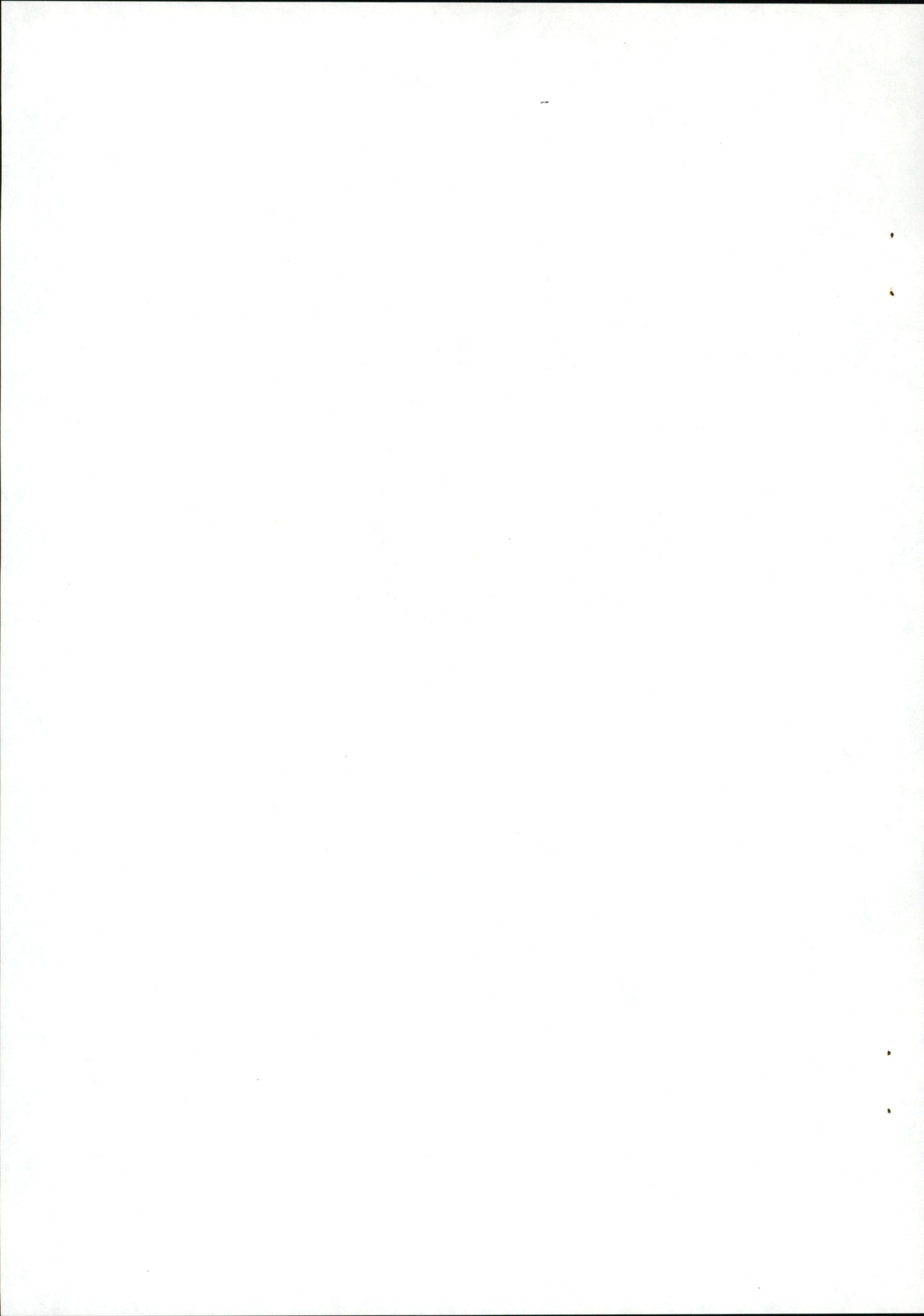
