

# Act No. 129, 1989

An Act to amend the Higher Education (Amalgamation) Act 1989 so as to provide for the transfer to the University of New England of the Orange Agricultural College; and for other purposes. [Assented to 30 August 1989]

## The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Higher Education (Amalgamation) Amendment Act 1989.

#### Commencement

2. (1) This Act commences on the date of assent.

(2) Part 8A of the Higher Education (Amalgamation) Act 1989 (as inserted by this Act) commences on a day to be appointed by proclamation under section 2 of that Act.

#### The Orange Agricultural College

17A. (1) The Orange Agricultural College is abolished and its Council is dissolved.

(2) The property of the Orange Agricultural College is vested in the University of New England (subject to any trusts or conditions subject to which it was held immediately before the commencement of this section) to be applied by the University for the purposes of the University of New England.

(3) The University of New England has the control and management of land that was under the control and management of the Orange Agricultural College immediately before the commencement of this section.

- (4) The Orange Agricultural College By-law 1984:
- (a) continues in force (in respect only of such part of the University of New England as comprises the institution that was, immediately before the commencement of this section, the Orange





#### **EXPLANATORY NOTE**

# (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the University of Sydney Bill 1989.

The object of this Bill is to amend the Higher Education (Amalgamation) Act 1989 so as:

- (a) to provide for the transfer to the University of New England of the Orange Agricultural College; and
- (b) to extend the regulation-making power under that Act as a consequence of enacting the cognate Bills.

Clause 1 specifies the short title of the proposed Act.


Clause 2 provides that the proposed Act commences on the date of assent.

Clause 3 is a formal provision that gives effect to the Schedule of amendments.

#### **SCHEDULE 1 - AMENDMENTS**

Schedule 1 (1) and (2) provide for the transfer to the University of New England of the Orange Agricultural College.

Schedule 1 (3) extends the regulation-making power of the Act as referred to above.


