Act No. 122, 1988

An Act to amend the Local Government Act 1919 as a consequence of the enactment of the Hunter Water Board Act 1988. [Assented to 21 December 1988]

Local Government (Hunter Water Board) Amendment 1988

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Local Government (Hunter Water Board) Amendment Act 1988.

Commencement

2. This Act commences on a day or days to be appointed by proclamation.

Amendment of Local Government Act 1919 No. 41

3. The Local Government Act 1919 is amended as set out in Schedule 1.

SCHEDULE 1—AMENDMENTS

(Sec. 3)

(1) Section 10 (**Certain Acts not affected**)—

After “the Water Board Act 1987;”, insert “the Hunter Water Board Act 1988;”.

(2) Section 327 (**Conditions to be observed before opening new roads or subdivisions**)—

(a) After section 327 (1) (d) (ii) (A) and (2) (b) (ii) (A), insert:

(A1) the Hunter Water Board’s area of operations, within the meaning of the Hunter Water Board Act 1988; or

(b) In section 327 (1) (d) (ii) and (2) (b) (ii), before “or section” wherever occurring, insert “, section 27 of the Hunter Water Board Act 1988”.

(3) Section 331A (**Subdivision of land within the area of operations of a Water Board or Water Supply Authority**)—

(a) After section 331A (1) (a) (i), insert:

(ia) the Hunter Water Board’s area of operations, within the meaning of the Hunter Water Board Act 1988; or

(b) In section 331A (1), after “Water Board” where lastly occurring, insert “, the Hunter Water Board”.

(c) In section 331A (2) and (3), before “or section” wherever occurring, insert “, section 27 of the Hunter Water Board Act 1988”.

SCHEDULE 1—AMENDMENTS—*continued*

(d) After section 331A (3) (a), insert:

- (ai) the Hunter Water Board's area of operations, within the meaning of the Hunter Water Board Act 1988; or

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Hunter Water Board Bill 1988.

The object of this Bill is to amend the Local Government Act 1919 as a consequence of the intended enactment of the Hunter Water Board Act 1988.


Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act is to commence on a day or days to be appointed by proclamation.

Clause 3 is a formal provision giving effect to the Schedule of amendments.

SCHEDULE 1—AMENDMENTS

Schedule 1 amends sections 10 (Certain Acts not affected), 327 (Conditions to be observed before opening new roads or subdivision) and 331A (Subdivision of land within the area of operations of a Water Board or Water Supply Authority) to include specific references to the Hunter Water Board and the Hunter Water Board Act 1988 because the Hunter Water Board will not be a Water Supply Authority within the meaning of the Water Supply Authorities Act 1987.

Local Government (Hunter Water Board) Amendment 1988

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Local Government (Hunter Water Board) Amendment Act 1988.

2. This Act commences on a day or days to be appointed by proclamation.
