

Act No. 30, 1990

An Act to amend the Local Government Act 1919, as a consequence of the enactment of the Liquor (Amendment) Act 1990 and the Registered Clubs (Amendment) Act 1990. [Assented to 14 June 1990]

## The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Local Government (Liquor) Amendment Act 1990.

#### Commencement

2. This Act commences on a day or days to be appointed by proclamation.

# Amendment of Local Government Act 1919 No. 41

- 3. The Local Government Act 1919 is amended:
- (a) by omitting from section 10 the matter "the Liquor Act, 1982;";
- (b) by omitting section 317JC.

## Transitional provision

4. An objection lodged with the Liquor Administration Board under Division 4B of Part 11 of the Local Government Act 1919 and not heard and determined by the Board before the commencement of section 3 may be heard and determined after that commencement as if section 3 had not commenced.

### **EXPLANATORY NOTE**

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Liquor (Amendment) Bill 1990.

The object of this Bill is to amend the Local Government Act 1919 as a consequence of the enactment of the Liquor (Amendment) Act 1990 and the Registered Clubs (Amendment) Act 1990.


Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

Clause 3 proposes to amend the Local Government Act 1919:

- (a) to repeal so much of section 10 of that Act as at present excludes the operation of that Act in relation to matters dealt with by the Liquor Act 1982 (clause 3 (a)); and
- (b) to make a consequential amendment (clause 3 (b)).

Clause 4 is a transitional provision.



# A BILL FOR

# The Legislature of New South Wales enacts:

## Short title

1. This Act may be cited as the Local Government (Liquor) Amendment Act 1990.

## Commencement

2. This Act commences on a day or days to be appointed by proclamation.
