



# Act No. 13, 1988

An Act to amend certain Acts as a consequence of the enactment of the Higher Education Act 1988; and for other purposes. [Assented to 21 June 1988]

#### The Legislature of New South Wales enacts:

# Short title

1. This Act may be cited as the Miscellaneous Acts (Higher Education) Amendment Act 1988.

#### Commencement

2. (1) This Act commences at the commencement of the Higher Education Act 1988, except as provided by subsection (2).

(2) The amendments to section 12 of the Colleges of Advanced Education Act 1975, section 17 of the Institute of the Arts Act 1987 and section 11 of the New South Wales State Conservatorium of Music Act 1965 (and section 3 in its application to those amendments) commence on a day to be appointed by proclamation.



# **EXPLANATORY NOTE**

# (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Higher Education Bill 1988.

The object of this Bill is to amend certain Acts-

- (a) to make the necessary consequential changes as a result of the abolition of the New South Wales Higher Education Board by the proposed Higher Education Act 1988; and
- (b) to remove any functions of the Public Service Board in connection with the staff of colleges of advanced education and similar higher education institutions.

Clause 1 specifies the short title of the proposed Act.

**Clause 2** provides that the proposed Act will commence at the commencement of the Higher Education Act 1988. However, the amendments relating to the functions of the Public Service Board are to commence on a day to be appointed by proclamation.

Clause 3 is a formal provision that gives effect to the Schedule of amendments to Acts.

# **Colleges of Advanced Education Act 1975**

The following amendments are made to the Act:

- Items (1), (2), (4), (5), (6) and (7) are consequential on the repeal of the Higher Education Act 1975 and the abolition of the Higher Education Board.

# **Institute of Rural Studies Act 1973**

The amendment made to the Act is consequential on the repeal of the Higher Education Act 1975.

The amendment made to the Act is consequential on the repeal of the Higher Education Act 1975.

# University of Technology, Sydney (Miscellaneous Provisions) Act 1987

The following amendments are made to the Act:

- Item (1) is consequential on the abolition of the Higher Education Board.
- Item (2) removes functions of the Public Service Board in relation to the determination of the non-academic staff establishment of the University of Technology, Sydney, the determination of conditions of employment of all staff and the representation of the University before industrial tribunals. These functions were to cease by 26 January 1989.
- Item (2) also removes a temporary requirement that the provision of academic courses by the University be subject to Ministerial control on the advice of the Higher Education Board.

#### **University of Wollongong Act 1972**

The amendment made to the Act is consequential on the repeal of the Higher Education Act 1975.


