Act No. 130, 1989

An Act to repeal the Colleges of Advanced Education Act 1975 and to amend certain other Acts as a consequence of that repeal; and for other purposes. [Assented to 30 August 1989]

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Miscellaneous Acts (Higher Education) Repeal and Amendment Act 1989.

Commencement

2. (1) This Act commences on the date of assent, except as otherwise provided by this section.

(2) Section 3 and Schedule 1 commence on a day to be appointed by proclamation.

(3) Item (3) of the provisions of Schedule 2 relating to the University of New England Act 1989 commence when Part 8A of the Higher Education (Amalgamation) Act 1989 commences.

Repeal of Colleges of Advanced Education Act 1975 No. 11

3. The Colleges of Advanced Education Act 1975 is repealed.

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the University of Sydney Bill 1989.

The objects of this Bill are:

- (a) to repeal the Colleges of Advanced Education Act 1975;
- (b) to amend certain other Acts as a consequence of that repeal; and
- (c) to make minor amendments to:
 - (i) the Charles Sturt University Act 1989;
 - (ii) the University of New England Act 1989;
 - (iii) the University of Newcastle Act 1989; and
 - (iv) the University of Technology, Sydney, Act 1989,so as to bring those Acts into line with the cognate Bills and so as to effect statute law revision.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act (with certain exceptions) on the date of assent. The repeal of the Colleges of Advanced Education Act 1975, and the provisions consequent on that repeal, are to commence on a proclaimed day. The provisions relating to the transfer of the Orange Agricultural College to the University of New England are to commence when the transfer takes place.

Miscellaneous Acts (Higher Education) Repeal and Amendment 1989

Clause 3 repeals the Colleges of Advanced Education Act 1975.

Clause 4 is a formal provision that gives effect to the Schedules of amendments.

Schedule 1 effects amendments consequent on the repeal of the Colleges of Advanced Education Act 1975.

Schedule 2 effects amendments as referred to in paragraph (c) above.
