EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Private Hospitals and Day Procedure Centres Bill 1988.

The object of this Bill is to amend certain Acts as a consequence of the repeal of the Private Health Establishments Act 1982 and the enactment of the Private Hospitals and Day Procedure Centres Act 1988 and the Nursing Homes Act 1988, which replace the 1982 Act.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act will commence on a day or days to be appointed by proclamation.

Clause 3 is a formal provision that gives effect to the Schedule of amendments to Acts.

SCHEDULE 1—AMENDMENT OF ACTS

Schedule 1 makes minor amendments to the following Acts as a consequence of the enactment of the Private Hospitals and Day Procedure Centres Act 1988 and the Nursing Homes Act 1988:

- Children (Care and Protection) Act 1987
- Disability Services and Guardianship Act 1987
- Medical Practitioners Act 1938
- Summary Offences Act 1988.

The amendments made by Schedule 1 substitute, in effect, references to the proposed Private Hospitals and Day Procedure Centres Act 1988 and Nursing Homes Act 1988 for references to the Private Health Establishments Act 1982 in the above Acts.




