EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Motor Vehicles Taxation Management Act 1949 to extend the categories of exemptions or partial exemptions from motor vehicles tax which may be granted by the Minister under that Act.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent.

Clause 3 amends section 7 (3) of the Principal Act to add 2 categories of exemptions or partial exemptions from motor vehicles tax which may be granted by the Minister, namely:

- motor vehicles used solely or principally by a State or private school for the purposes of driver education for school children; and
 - motor vehicles registered by or on behalf of Police-Citizens Youth Clubs which are used solely or principally for the purposes of any such club.

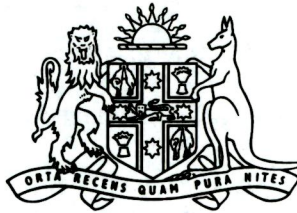
