

## Act No. 80, 1988

An Act to amend the Public Authorities (Financial Arrangements) Act 1987 in relation to government guarantees of repayment of financial accommodation. [Assented to 23 November 1988] Public Authorities (Financial Arrangements) Amendment 1988

#### The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Public Authorities (Financial Arrangements) Amendment Act 1988.

#### Commencement

2. This Act commences on a day to be appointed by proclamation.

3. The Public Authorities (Financial Arrangements) Act 1987 is amended by omitting section 15 (1) (b) and by inserting instead the following paragraph:

(b) such other forms of financial accommodation obtained by an authority as may be prescribed, whether or not involving the issue of securities of any kind,

#### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)


This Bill is cognate with the Treasury Corporation (Amendment) Bill 1988.

The object of this Bill is to amend the Public Authorities (Financial Arrangements) Act 1987 so as to make it clear that regulations may be made prescribing kinds of financial accommodation (including financial accommodation obtained by the Treasury Corporation) that receive the benefit of the government guarantee under that Act, whether or not they involve the issue of securities.

Clause 1 specifies the short title of the proposed Act.

**Clause 2** provides that the proposed Act is to commence on a day to be appointed by proclamation.

Clause 3 amends section 15 of the Principal Act so as to achieve the object of the proposed Act.




