EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the State Pollution Control Commission Act 1970 so as to provide for an additional member of the Commission to be appointed to represent employees.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act is to commence on a day to be appointed by proclamation.

Clause 3 is a formal provision that gives effect to the Schedule of amendments to the Principal Act.

Schedule 1 amends section 6 (Constitution of the Commission) of the Principal Act to provide for the appointment of an additional member of the Commission by the Governor on the nomination of the Minister to represent employees.






