**Act No. 51, 1988**

An Act to apply certain sums out of the Consolidated Fund towards the services of the Year 1988–1989. [Assented to 30 September 1988]

**The Legislature of New South Wales enacts:****Short title**

1. This Act may be cited as the Supply Act 1988.

**Commencement**

2. This Act shall commence on the date of assent.

**\$1,786,009,500 may be issued out of the Consolidated Fund for recurrent services**

3. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$1,786,009,500 to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1989, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

**\$249,537,000 may be issued out of the Consolidated Fund for capital works and services**

4. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$249,537,000 to meet the capital works and services expenditure of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1989, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

**Treasurer's authority to pay sums appropriated**

5. The Treasurer shall issue and pay the sums appropriated by this Act in such manner and in such proportions as may be necessary in the public interest to provide for expenditure for the purposes referred to in sections 3 and 4.

**Treasurer to have credit and receipts to discharge Treasurer**

6. The Treasurer shall in the Treasurer's account from time to time be allowed credit for all sums of money paid by the Treasurer pursuant to section 5, and the receipts of the respective persons to whom those sums

shall be so paid shall be full and valid discharges to the Treasurer in passing the Treasurer's accounts for such sums as shall be therein mentioned, and the Treasurer shall receive credit for those sums accordingly.

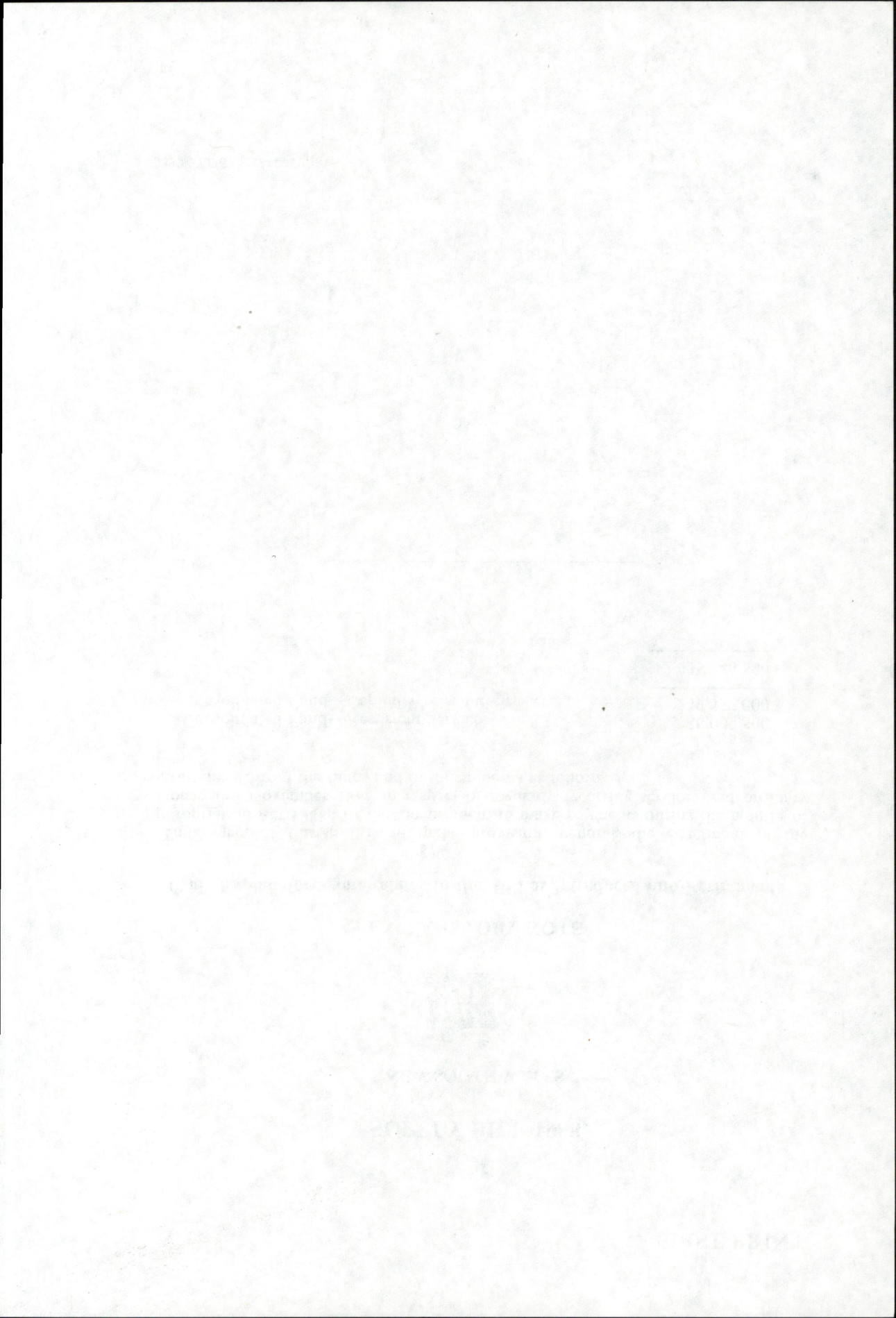


## EXPLANATORY NOTE

**The Legislature of New South Wales enacts:****Short title**

1. This Act may be cited as the Supply Act 1988.

**Commencement**

- 5 2. This Act shall commence on the date of assent.

**\$1,786,009,500 may be issued out of the Consolidated Fund for recurrent services**

3. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$1,786,009,500 to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1989, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

**\$249,537,000 may be issued out of the Consolidated Fund for capital works and services**

4. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$249,537,000 to meet the capital works and services expenditure of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1989, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

**Treasurer's authority to pay sums appropriated**

5. The Treasurer shall issue and pay the sums appropriated by this Act in such manner and in such proportions as may be necessary in the public interest to provide for expenditure for the purposes referred to in sections 3 and 4.

**Treasurer to have credit and receipts to discharge Treasurer**

6. The Treasurer shall in the Treasurer's account from time to time be allowed credit for all sums of money paid by the Treasurer pursuant to section 5, and the receipts of the respective persons to whom those sums shall be so paid shall be full and valid discharges to the Treasurer in passing the Treasurer's accounts for such sums as shall be therein mentioned, and the Treasurer shall receive credit for those sums accordingly.
