#### **EXPLANATORY NOTE**


## (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend section 18B (Penalty notices for certain offences) of the Traffic Act 1909 to enable penalty ("on-the-spot") notices to be issued for particular offences under the Transport Licensing Act 1931, the Motor Vehicle Driving Instructors Act 1961 and the Motor Vehicles Taxation Act 1988 and the regulations made under those Acts.

The particular offences will be prescribed by the regulations under section 18B.

Clause 1 specifies the short title of the proposed Act.

Clause 2 makes the amendment described above.


