**BUSINESS FRANCHISE LICENCES (PETROLEUM
PRODUCTS) AMENDMENT BILL 1992**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Appropriation Bill 1992.

The object of this Bill is to amend the Business Franchise Licences (Petroleum Products) Act 1987 to increase the fees to be paid for licences under that Act.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on 1 October 1992.

Clause 3 amends section 40 of the Principal Act so as to increase the fees to be paid for licences under that Act by about 2.9 per cent.

Clause 4 provides that the increased fees are to apply in respect of licences that take effect on or after 1 November 1992.

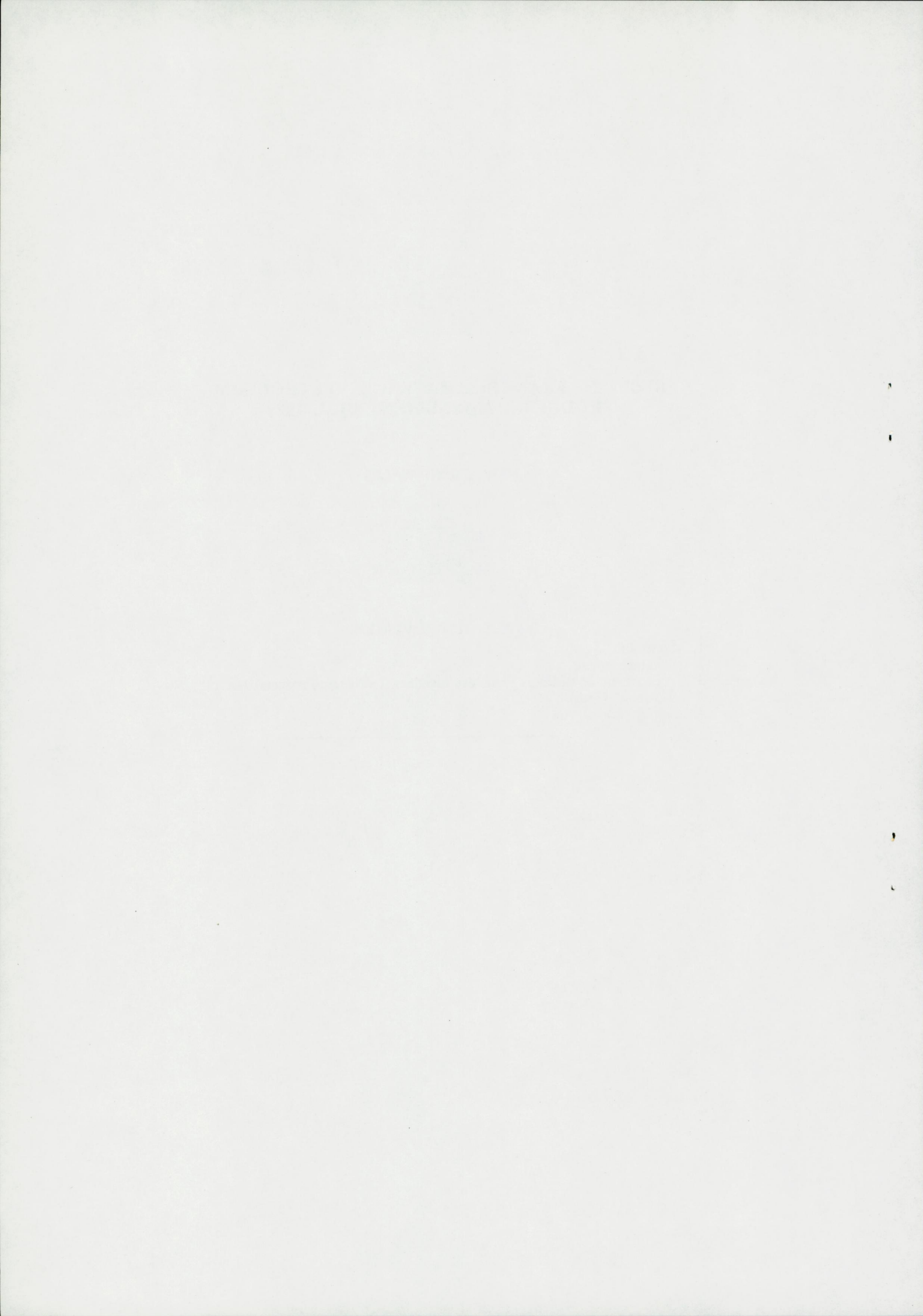

Business Franchise Licences (Petroleum Products) Amendment 1992

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Business Franchise Licences (Petroleum Products) Amendment Act 1992.

5 Commencement

2. This Act commences or is taken to have commenced on 1 October 1992.
