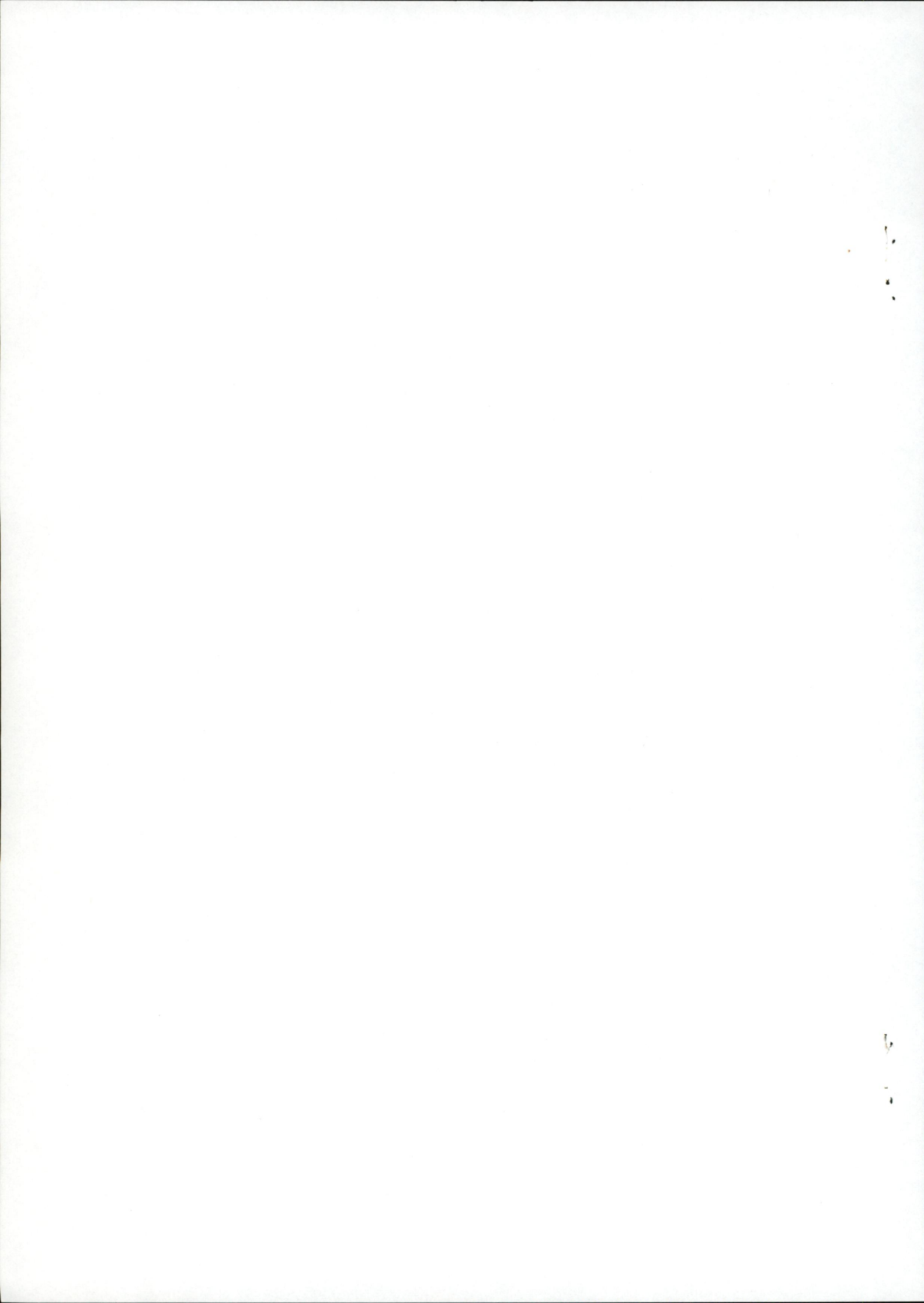
EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Appropriation Bill 1994.

The object of this Bill is to appropriate out of the Consolidated Fund the following sums for the recurrent services and the capital works and services of the Legislature for the year 1994-95:

Recurrent services	\$55,296,000
Capital works and services	\$2,280,000

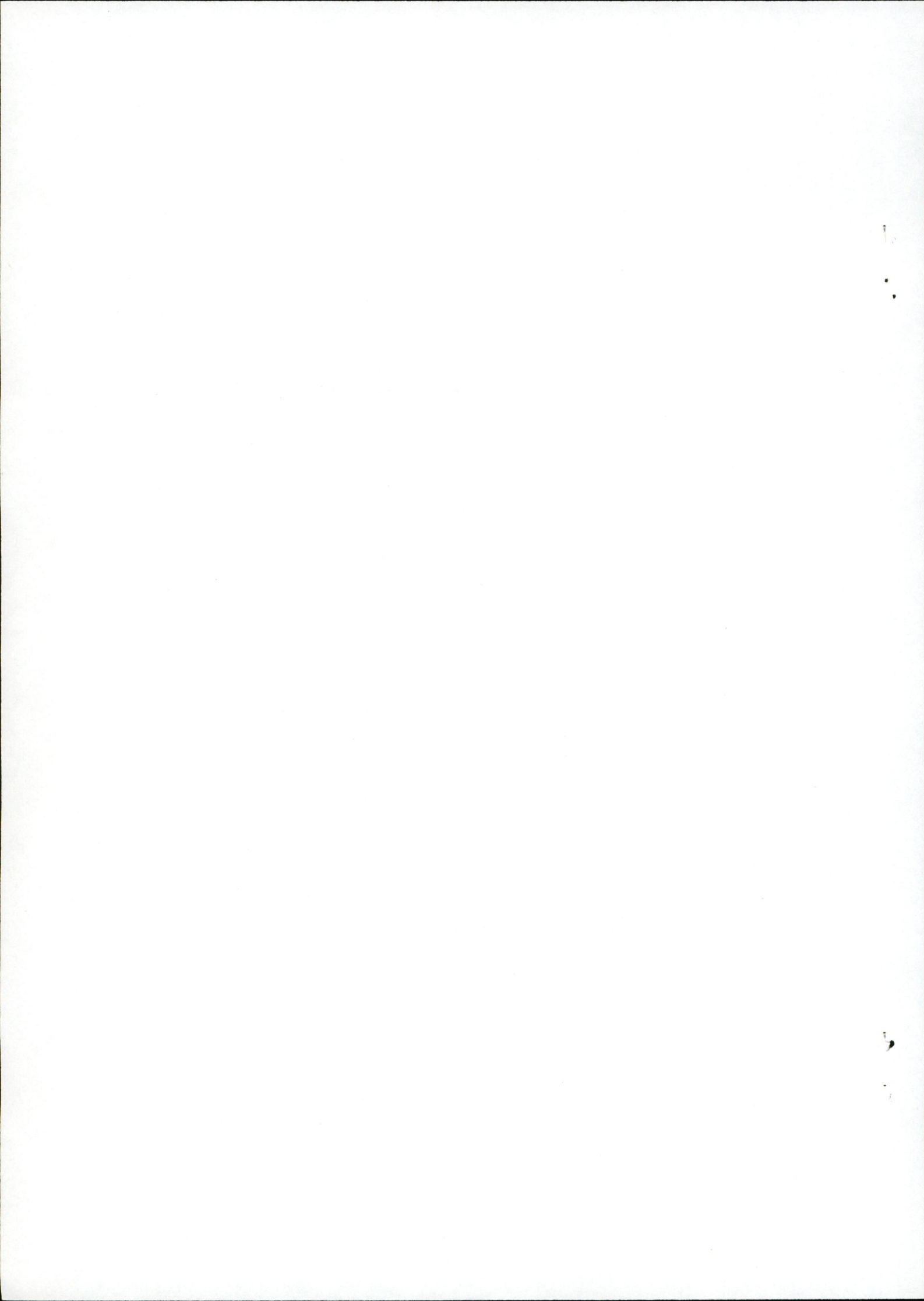

A BILL FOR

An Act to appropriate out of the Consolidated Fund sums for the recurrent services and capital works and services of the Legislature for the year 1994–95.

Parliamentary Appropriation 1994

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Parliamentary Appropriation Act 1994.

5 Commencement

2. This Act commences on the date of assent.

Interpretation

3. (1) In this Act:

10 (a) a reference to the year 1993–94 is a reference to the year from 1 July 1993 to 30 June 1994; and

(b) a reference to the year 1994–95 is a reference to the year from 1 July 1994 to 30 June 1995.

(2) A reference in the Public Finance and Audit Act 1983 to an or the Appropriation Act includes a reference to this Act.

15 Appropriation for recurrent services

4. (1) This Act appropriates the sum of \$55,296,000 to the Legislature out of the Consolidated Fund for the recurrent services of the Legislature for the year 1994–95.

20 (2) Any amounts expended for recurrent services under section 25 of the Public Finance and Audit Act 1983 or any Parliamentary Supply Act on or after 1 July 1994 and before the date of assent to this Act are taken to have been expended out of the sum appropriated by this section.

Appropriation for capital works and services

25 5. (1) This Act appropriates the sum of \$2,280,000 to the Legislature out of the Consolidated Fund for the capital works and services of the Legislature for the year 1994–95.

30 (2) Any amounts expended for capital works and services under section 25 of the Public Finance and Audit Act 1983 or any Parliamentary Supply Act on or after 1 July 1994 and before the date of assent to this Act are taken to have been expended out of the sum appropriated by this section.

Variation of authorised payments from Consolidated Fund

6. (1) Payment of the sums appropriated under this Act may not be made on a program shown in the Budget Paper entitled "Budget

Parliamentary Appropriation 1994

Estimates 1994–95” in excess of the sums provided in that Budget Paper for the program, except as provided by this section and Division 4 of Part 2 of the Public Finance and Audit Act 1983.

(2) If the exigencies of the Public Service render it necessary, the Treasurer may authorise: 5

(a) the payment of a sum in excess of the amount shown in the Budget Paper entitled “Budget Estimates 1994–95” as the Consolidated Fund Recurrent Payments estimate for a program, but only on the condition that an equivalent sum is not paid out of the estimate of the Consolidated Fund Recurrent Payments for another program; and 10

(b) the payment of a sum in excess of the amount shown in that Budget Paper as the Consolidated Fund Capital Payments estimate for a program, but only on the condition that an equivalent sum is not paid out of the estimate of the Consolidated Fund Capital Payments for another program. 15

(3) This section does not apply to sums appropriated otherwise than by this Act.

(4) This section does not empower the Treasurer to authorise the payment of a sum in augmentation of or as an addition to any salary or wages the amount of which has been fixed by law. 20

(5) The Treasurer is required to inform the Auditor-General of every authorisation given under this section.

Appointment of person to carry out the functions of the Treasurer under section 6 25

7. (1) The Treasurer may appoint a person to carry out the Treasurer’s functions under section 6.

(2) Any such appointment is subject to such conditions (if any) as the Treasurer determines.

(3) The Treasurer may revoke any such appointment at any time. 30

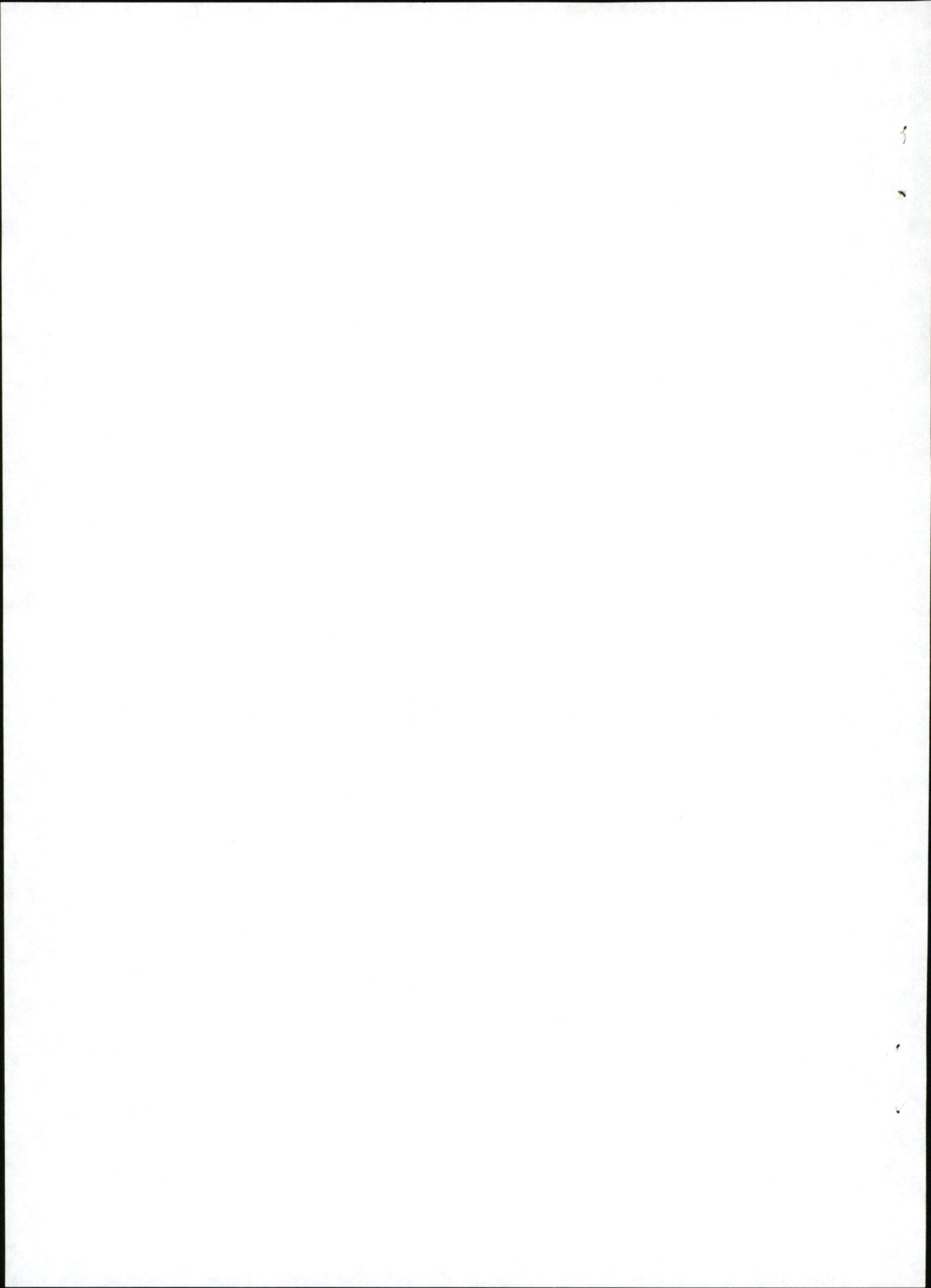

Act No. 67, 1994

An Act to appropriate out of the Consolidated Fund sums for the recurrent services and capital works and services of the Legislature for the year 1994–95. [Assented to 23 November 1994]

The Legislature of New South Wales enacts:**Short title**

1. This Act may be cited as the Parliamentary Appropriation Act 1994.

Commencement

2. This Act commences on the date of assent.

Interpretation

3. (1) In this Act:

- (a) a reference to the year 1993–94 is a reference to the year from 1 July 1993 to 30 June 1994; and
- (b) a reference to the year 1994–95 is a reference to the year from 1 July 1994 to 30 June 1995.

(2) A reference in the Public Finance and Audit Act 1983 to an or the Appropriation Act includes a reference to this Act.

Appropriation for recurrent services

4. (1) This Act appropriates the sum of \$55,296,000 to the Legislature out of the Consolidated Fund for the recurrent services of the Legislature for the year 1994–95.

(2) Any amounts expended for recurrent services under section 25 of the Public Finance and Audit Act 1983 or any Parliamentary Supply Act on or after 1 July 1994 and before the date of assent to this Act are taken to have been expended out of the sum appropriated by this section.

5. (1) This Act appropriates the sum of \$2,280,000 to the Legislature out of the Consolidated Fund for the capital works and services of the Legislature for the year 1994–95.

(2) Any amounts expended for capital works and services under section 25 of the Public Finance and Audit Act 1983 or any Parliamentary Supply Act on or after 1 July 1994 and before the date of assent to this Act are taken to have been expended out of the sum appropriated by this section.

Variation of authorised payments from Consolidated Fund

6. (1) Payment of the sums appropriated under this Act may not be made on a program shown in the Budget Paper entitled "Budget Estimates 1994-95" in excess of the sums provided in that Budget Paper for the program, except as provided by this section and Division 4 of Part 2 of the Public Finance and Audit Act 1983.

(2) If the exigencies of the Public Service render it necessary, the Treasurer may authorise:

- (a) the payment of a sum in excess of the amount shown in the Budget Paper entitled "Budget Estimates 1994-95" as the Consolidated Fund Recurrent Payments estimate for a program, but only on the condition that an equivalent sum is not paid out of the estimate of the Consolidated Fund Recurrent Payments for another program; and
- (b) the payment of a sum in excess of the amount shown in that Budget Paper as the Consolidated Fund Capital Payments estimate for a program, but only on the condition that an equivalent sum is not paid out of the estimate of the Consolidated Fund Capital Payments for another program.

(3) This section does not apply to sums appropriated otherwise than by this Act.

(4) This section does not empower the Treasurer to authorise the payment of a sum in augmentation of or as an addition to any salary or wages the amount of which has been fixed by law.

(5) The Treasurer is required to inform the Auditor-General of every authorisation given under this section.

Appointment of person to carry out the functions of the Treasurer under section 6

7. (1) The Treasurer may appoint a person to carry out the Treasurer's functions under section 6.

Parliamentary Appropriation Act 1994 No. 67

(2) Any such appointment is subject to such conditions (if any) as the Treasurer determines.

(3) The Treasurer may revoke any such appointment at any time.
