#### EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to formalise the appointment of Mr Donald Keith Wilson to the position of Inspector General in the Police Service.

This position is within the Police Service Senior Executive Service. The appointment of persons to positions in that Senior Executive Service is covered by the Police Service Act 1990.


The Act provides for the appointment of a suitable person to a vacant position in the Police Service Senior Executive Service without the vacancy being advertised but only if the person recommended for appointment is employed either as a police officer or an administrative officer in the Police Service. As the vacancy was not advertised and Mr Wilson was not employed in either of those categories, his appointment is not covered by the Act.

The appointment made by this Bill will be for a period of 3 years from 29 July 1991, when he took up employment in the Police Service on a temporary basis.

Clause 1 specifies the short title of the proposed Act.

Clause 2 provides that the proposed Act commences on the date of assent.

Clause 3 makes the appointment described above.



# A BILL FOR

An Act to make special provision regarding an appointment to the position of Inspector General in the Police Service.

Police Service (Inspector General) 1991

#### The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Police Service (Inspector General) Act 1991.

#### Commencement

2. This Act commences on the date of assent.

#### Special appointment as Inspector General

3. (1) This Act applies to Mr Donald Keith Wilson who commenced duty in the Police Service on 29 July 1991.

(2) Mr Wilson is taken for all purposes to have been duly appointed under the Police Service Act 1990 on 29 July 1991 to the position of Inspector General in the Police Service (being a position in the Police Service Senior Executive Service) for a period of 3 years commencing on that date.

(3) This appointment is taken to have been effected by an instrument of appointment executed by the Governor on the recommendation of the Police Board and specifying that period as his term of office.

(4) The appointment under this section has effect despite anything in the Police Service Act 1990.



Police Service (Inspector General) 1991

#### The Legislature of New South Wales enacts:

#### Short title

1. This Act may be cited as the Police Service (Inspector General) Act 1991.

#### Commencement

2. This Act commences on the date of assent.

#### Special appointment as Inspector General

3. (1) This Act applies to Mr Donald Keith Wilson who commenced duty in the Police Service on 29 July 1991.

(2) Mr Wilson is taken for all purposes to have been duly appointed under the Police Service Act 1990 on 29 July 1991 to the position of Inspector General in the Police Service (being a position in the Police Service Senior Executive Service) for a period of 3 years commencing on that date.
