EXPLANATORY NOTE

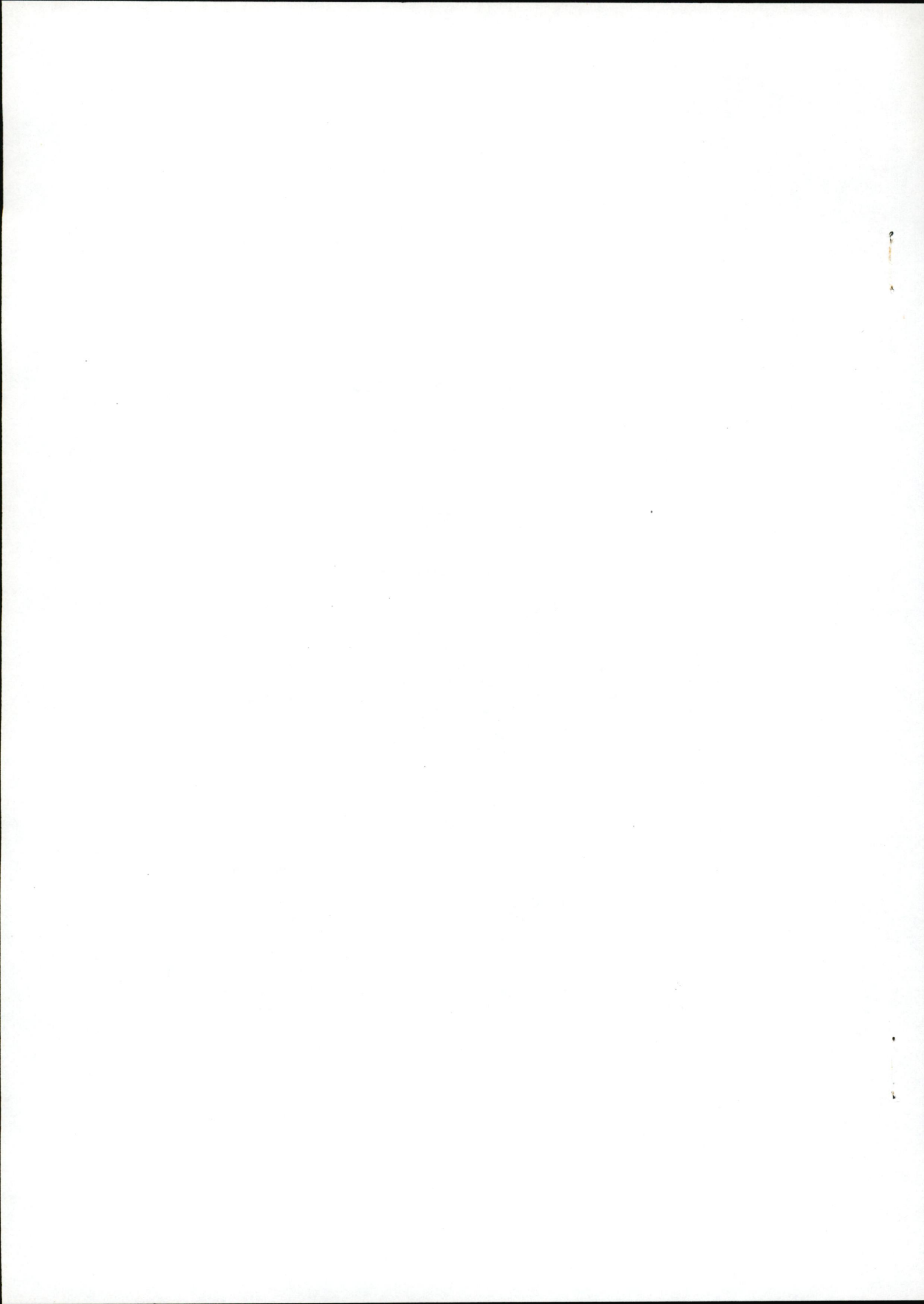
(This Explanatory Note relates to this Bill as introduced into Parliament)

Pending the enactment of the annual Appropriation Act, the Treasurer is authorised, under section 25 of the Public Finance and Audit Act 1983, to make payments from the Consolidated Fund during the first 3 months of the new financial year (July, August and September) in respect of regularly recurring services and ordinary contingencies. Those payments are, on the passing of the Appropriation Act, to be regarded as having been made out of money appropriated by that Act.

The object of this Bill is to make provision, pending the enactment of this year's Appropriation Act, for the Treasurer to make payments from the Consolidated Fund during the months of October and November in respect of regularly recurring services and ordinary contingencies as follows:

The Appropriation Act will contain a provision to the effect that amounts expended under the Supply Act are to be regarded as having been made out of money appropriated by the Appropriation Act.

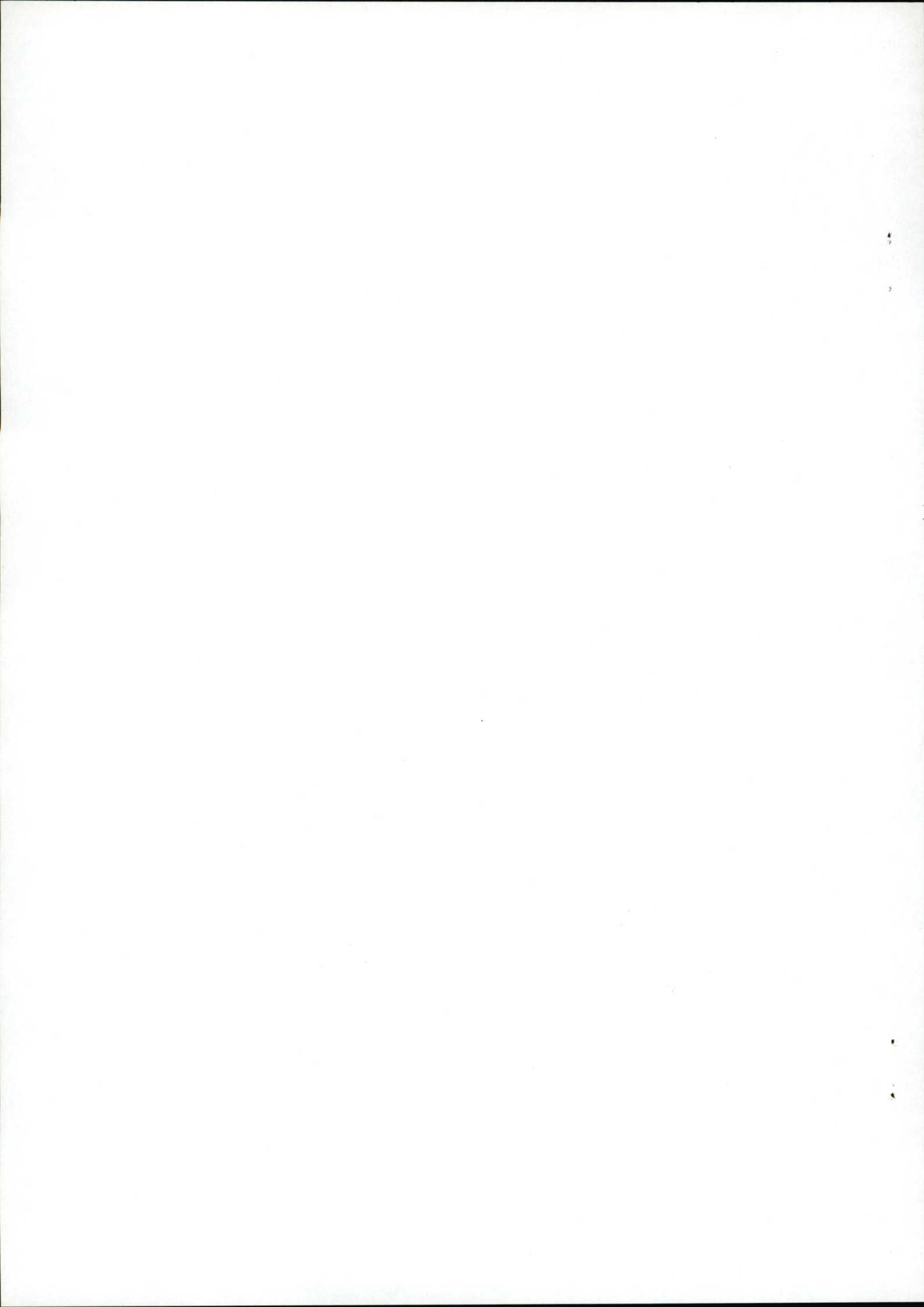

A BILL FOR

An Act to apply certain sums out of the Consolidated Fund towards the services of the year 1993–1994.

The Legislature of New South Wales enacts:

Short title

1. This Act may be cited as the Supply Act 1993.

Commencement

- 5 2. This Act commences on the date of assent.

\$2,635,109,000 may be issued out of the Consolidated Fund for recurrent services

- 10 3. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$2,635,109,000 to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1994, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

\$830,842,000 may be issued out of the Consolidated Fund for capital works and services

- 15 4. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$830,842,000 to meet the capital works and services expenditure of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1994, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

Treasurer's authority to pay sums appropriated

- 20 5. The Treasurer may issue and pay the sums appropriated by this Act in such manner and in such proportions as may be necessary in the public interest to provide for expenditure for the purposes referred to in sections 3 and 4.

Act No. 51, 1993

An Act to apply certain sums out of the Consolidated Fund towards the services of the year 1993–1994. [Assented to 21 September 1993]

The Legislature of New South Wales enacts:**Short title**

1. This Act may be cited as the Supply Act 1993.

Commencement

2. This Act commences on the date of assent.

\$2,635,109,000 may be issued out of the Consolidated Fund for recurrent services

3. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$2,635,109,000 to defray the expenses of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1994, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

\$830,842,000 may be issued out of the Consolidated Fund for capital works and services

4. Out of the Consolidated Fund there is hereby appropriated and may be issued and applied the sum of \$830,842,000 to meet the capital works and services expenditure of the various Departments and Services of the State during the months of October and November of the financial year ending 30 June 1994, subject to the rate of any reduction that may hereafter be made in the expenditure of that year.

Treasurer's authority to pay sums appropriated

5. The Treasurer may issue and pay the sums appropriated by this Act in such manner and in such proportions as may be necessary in the public interest to provide for expenditure for the purposes referred to in sections 3 and 4.
