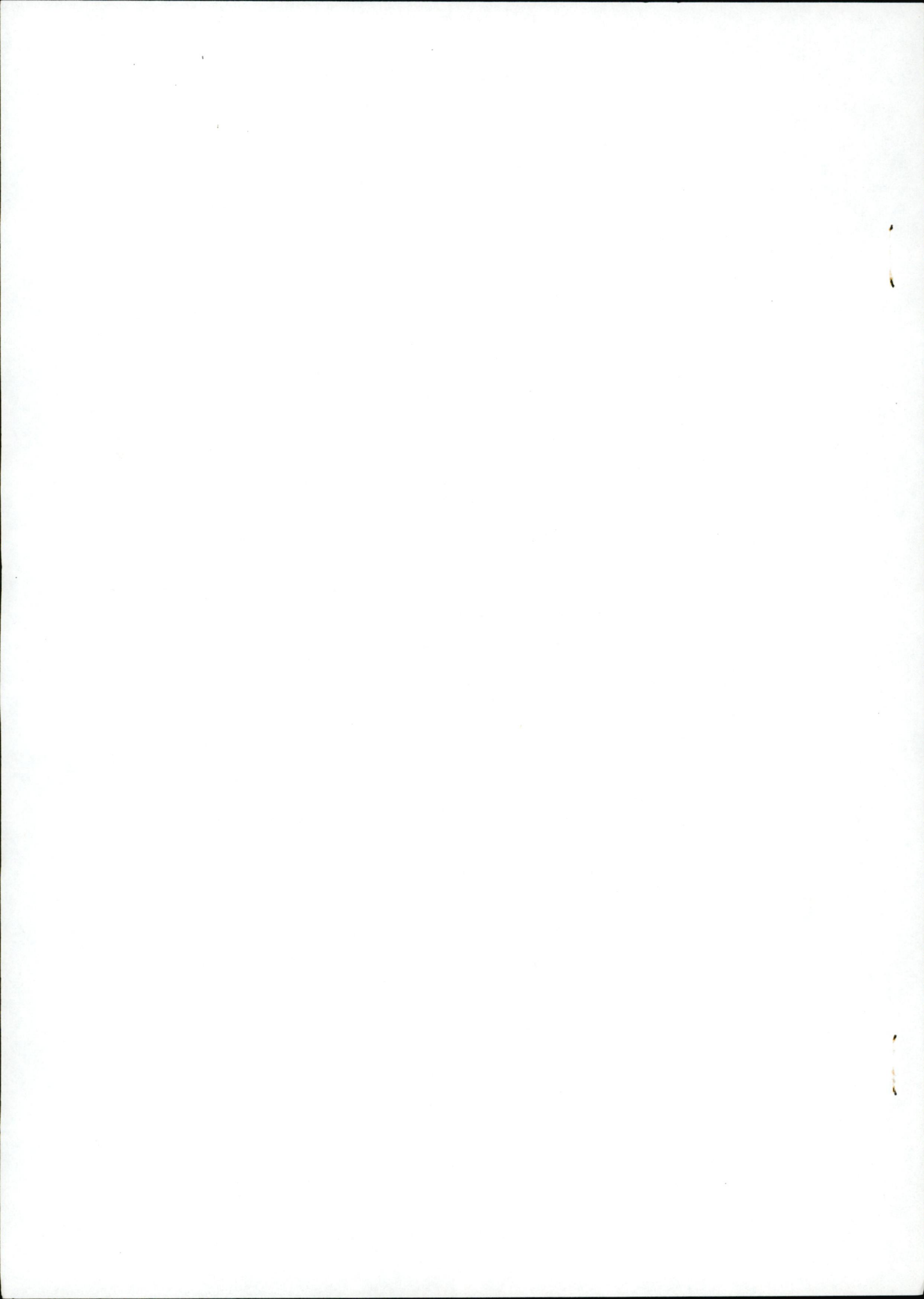
**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

The object of this Bill is to amend the Zoological Parks Board Act 1973 to clarify the objectives of the Board in establishing and managing zoological parks.

The objectives of the Board are:

- (a) to carry out research and breeding programs for the preservation of endangered species; and
  - (b) to carry out research programs for the conservation and protection of other species; and
  - (c) to conduct public education and awareness programs about species conservation and protection; and
  - (d) to display animals for educational, cultural and recreational purposes.

  - (c) may provide educational services for the public (whether in the nature of lectures, broadcasts, films, publications or otherwise) about species conservation and protection, zoological parks and the biology of animals; and
  - (d) may provide and charge for such services in connection with zoological parks maintained and controlled by the Board as the Board may determine; and
  - (e) may make recommendations or reports to the Minister with respect to matters connected with the Board’s powers, authorities, duties and functions or the administration of this Act.

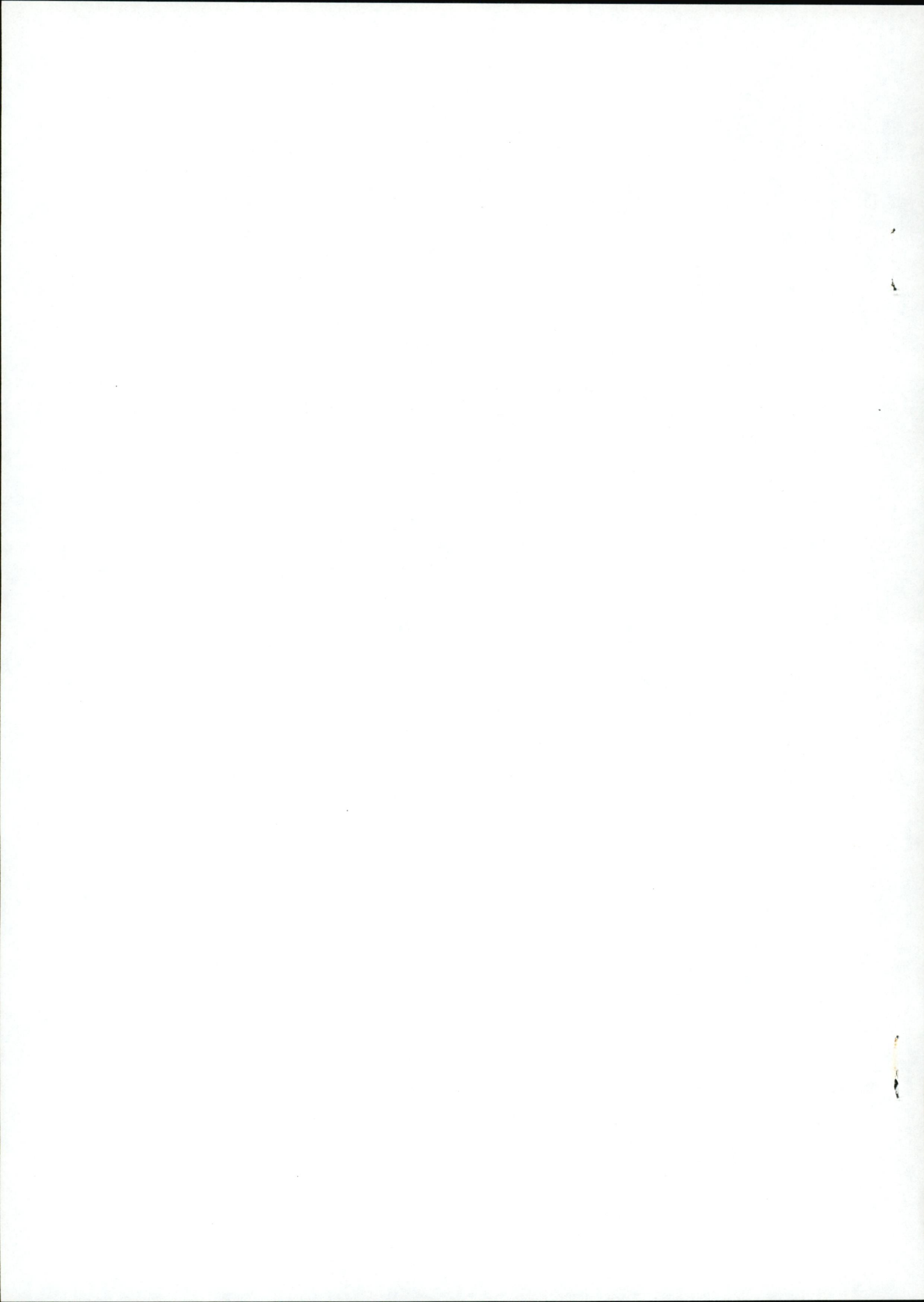

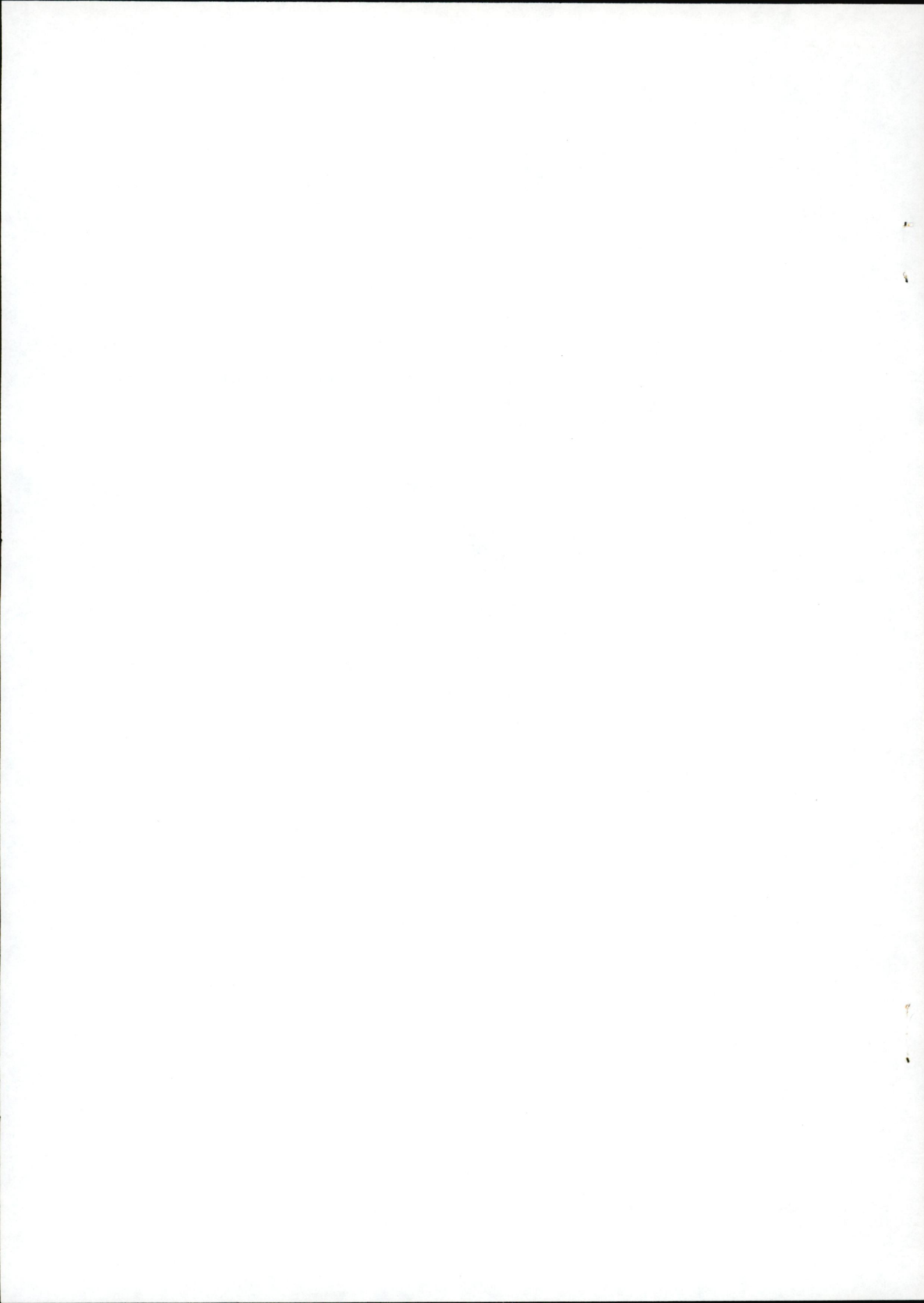
