

# Banana Industry Amendment Bill 1996

## **Explanatory note**

This explanatory note relates to this Bill as introduced into Parliament.

#### Overview of Bill

The objects of this Bill are to amend the Banana Industry Act 1987 as follows:

- (a) to reconstitute the membership of the Banana Industry Committee ("the Committee"), so that some of the members of the Committee are elected by banana growers to represent particular regions of the banana industry and to provide for the election of those regional members,
- (b) to change the voting entitlements of banana growers in polls, and to provide for similar entitlements in elections, so that banana growers will be able to cast up to 3 votes each depending on the size of the plantation on which bananas are grown by or on behalf of the grower,
- (c) to provide that banana growers are not entitled to vote in a poll or election unless they are fully paid up as regards charges, fees or other amounts due and payable to the Committee in respect of the previous financial year,

- (d) to allow the Committee to fund groups or bodies who assist the Committee in the exercise of the Committee's functions,
- (e) to remove the requirement that one of the members appointed by the Minister to the Committee be a public servant,
- (f) to make other minor and consequential amendments.

#### Outline of provisions

Clause 1 sets out the name (also called the short title) of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on a day or days to be proclaimed.

Clause 3 gives effect to the amendments to the Banana Industry Act 1987 as set out in Schedule 1.

#### Schedule 1 Amendments

#### Reconstitution of Banana Industry Committee

At present the Banana Industry Committee consists of 2 ministerial appointees and the persons holding office for the time being as members of the Board of Directors of the Banana Growers Federation Co-operative Limited ("the Federation").

The amendments to the Act contained in this Bill replace the Committee members who are Directors of the Federation with regional members. One regional member of the Committee is to be elected for each region of the banana industry. The Minister is to determine, by order, the number of regions to be represented on the Committee and the boundaries of those regions. In the event that the Minister makes a further determination that changes the boundaries of the regions to be represented on the Committee, a new election of members for the regions affected is required to be held. (See Schedule 1 [2], [3] and [4])

Savings and transitional provisions remove from office the members of the Committee who presently hold office by virtue of being Directors of the Federation. (See Schedule 1 [33])

The Minister is given the power to determine different terms of office for each of the first elected members of the Committee, so that their terms of office need not expire at the same time. (See Schedule 1 [33])

#### Election of regional members

New Part 4A provides for the election of regional members of the Committee by banana growers whose plantations are situated within the region concerned. The provisions relating to the conduct of elections are similar to existing provisions in the Act relating to the conduct of polls of banana growers. The regulations may provide that application for enrolment in the list of voters compiled for an election, and voting in an election, is compulsory. (See Schedule 1 [15], [20], [21] and [22])

If a banana grower has a plantation that is situated in more than one region, provision is made for the nomination by the banana grower of the region in which he or she is entitled to vote. (See Schedule 1 [15])

Regional members of the Committee hold office for a period of 3 years, subject to provisions in the Act relating to vacancies in office. The Minister may appoint a person to fill a vacancy in the office of a regional member in certain circumstances. (See Schedule 1 [24], [25] and [26])

#### **Multiple votes**

The voting entitlements of banana growers are changed so that in a poll conducted under the Act, or an election of a regional member, a banana grower will be entitled to cast up to 3 votes, depending on the size of the banana grower's plantation. If the plantation has an area that does not exceed 4 hectares, the banana grower is entitled to one vote. If the plantation has an area that exceeds 4 hectares but does not exceed 8 hectares, the banana grower is entitled to 2 votes. If the plantation has an area that exceeds 8 hectares, the banana grower is entitled to 3 votes. The maximum number of votes that a banana grower will be entitled to cast in an election or poll will be 3 votes (regardless of whether the banana grower has an interest in more than one plantation). Regulations may be made relating to the method of determining a person's entitlement to vote. (See Schedule 1 [10], [15] and [23])

At present, where 2 or more persons are banana growers in relation to one plantation, only one of them is entitled to vote in a poll. This rule is extended to elections. (See Schedule 1 [15])

Regulations may provide for voting entitlements where there is more than one banana grower in relation to a plantation. (See Schedule 1 [10], [12] and [15])

When compiling a list of voters for a poll or election, the Minister will be required to include the voting entitlements of those voters in the list. A person who is dissatisfied with the determination as to his or her voting entitlement will be able to apply for review by a Local Court. (See Schedule 1 [8] and [15])

#### Entitlement to vote

A banana grower will not be entitled to vote in a poll or an election of a regional member if the grower has not paid all charges, fees and other amounts due and payable to the Committee under the Act in respect of the previous financial year by the close of enrolments for the poll or election. (See Schedule 1 [13] and [15])

#### Funding of groups

At present the Committee may fund any scheme or activity that, in the Committee's opinion, is capable of assisting in the promotion or sale of bananas. The amendments also give the Committee power to fund any group or body that assists the Committee in the exercise of the Committee's functions. (See Schedule 1 [5])

# Removal of requirement that a member of the Committee be a public servant

At present one of the 2 members of the Committee appointed by the Minister must be a public servant. This requirement is removed. (See Schedule 1 [3] and [27])

#### Other minor and consequential amendments


The current Chairperson of the Committee is removed from office. Instead the Chairperson is to be elected by regional members from their number. (See Schedule 1 [29] and [33])

The definition of *advertisement* is extended to include an advertisement that appears in an official publication of the Committee (so that, for instance, a poll can be advertised in a Committee publication). (See Schedule 1 [1] and [17])

Some references to the functions of the Federation that are now obsolete are removed. (See Schedule 1 [11] and [14])

A provision of the Act is relocated to make it clear that persons acting under the direction of the Committee are not personally liable for acts done in good faith. In addition, the provision is extended to make it clear that liability for omissions is also excluded. (See Schedule 1 [16] and [28]) Sections 27 and 30 of the Act are repealed by way of statute law revision. Those sections are general provisions that make contravention of the Act an offence and render the person guilty of such an offence liable to a penalty of up to 20 penalty units (\$2,000). The Bill replaces those provisions by specifying the maximum penalty for each offence against the Act under the offence concerned. (See Schedule 1 [6], [7], [9], [18] and [19])

Some of the provisions of Schedule 3 (Savings, transitional and other provisions) are rearranged, as a consequence of the insertion of new provisions in that Schedule. (See Schedule 1 [30], [31] and [32])



#### A Bill for

An Act to amend the *Banana Industry Act 1987* to reconstitute the Banana Industry Committee; to amend the voting entitlements of banana growers; and for other purposes.

### The Legislature of New South Wales enacts:

#### 1 Name of Act

This Act is the Banana Industry Amendment Act 1996.

#### 2 Commencement

This Act commences on a day or days to be appointed by proclamation.

- (1) For the purposes of a poll, the Minister is to cause a list to be compiled, in accordance with the regulations, of banana growers who are entitled to vote in a poll and of the number of votes those banana growers are entitled to cast in the poll.
- (2) If, after application made in accordance with the regulations for the purpose, a person is not satisfied with the result of the application, that person may apply as prescribed to a Local Court for an order that the name of the person or a particular voting entitlement for the person be included in the list.
- (3) The Local Court has the jurisdiction to hear and determine the matter of the application and may:
  - (a) order that the name of the applicant be included in the list or that a particular voting entitlement for the person be included in the list, or
  - (b) dismiss the application.

#### 15 One banana grower to vote per plantation

- (1) For the purposes of a poll, if 2 or more persons are banana growers in relation to one plantation:
  - (a) only one of them is entitled to vote in respect of that plantation in the poll, and
  - (b) both or all of them may, by agreement, nominate in writing addressed to the Chairperson which of them is entitled to vote, and
  - (c) if a nomination is not made under paragraph (b), the Chairperson is to determine the person who is entitled to vote.
- (2) If a person is a banana grower in relation to more than one plantation, this section is subject to any regulations under section 12A. For example, the regulations may provide that if 2 or more persons are banana growers in relation to more than one plantation, only one of them is entitled to vote in the poll in respect of all or any of those plantations.

# 15A Banana grower must be fully paid up to be entitled to vote in poll

A person is not entitled to vote in a poll if the person has not paid all charges, fees and other amounts due and payable to the Committee under this Act in respect of the financial year last preceding the poll by the close of enrolments for the poll under the regulations.

# Part 4A Election of regional members of Committee

#### 16A Regional members to be elected

16C.

- (1) A regional member is to be elected, in accordance with the regulations, by banana growers who are entitled to vote in the election for the region concerned.
- (2) One regional member is to represent each region.
- (3) The regulations may make provision for or with respect to the persons who are entitled to be nominated as candidates for election as regional members. A person's nomination is invalid if the person is not entitled to be so nominated.

#### 16B Banana growers who are entitled to vote in election

- (1) Subject to this Part, a banana grower is entitled to vote in the election of a regional member if bananas are grown by or on behalf of the banana grower on a plantation that is situated within the region concerned.
- (2) If bananas are grown by or on behalf of a banana grower on plantations that are situated in different regions or on a plantation that is situated partly in one region and partly in another region, the banana grower is entitled to vote in an election in respect of one region only. That region is to be the region duly nominated by the banana grower or determined by the Chairperson under section

#### 16C Nomination of region

- (1) A banana grower who is otherwise entitled to vote in an election may at any time, by notice in writing given to the Chairperson, nominate the region in respect of which he or she intends to vote. The nomination is not valid unless the banana grower is a banana grower in relation to a plantation that is wholly or partly situated in that region.
- (2) The Chairperson may at any time, by notice in writing to a banana grower, require the banana grower to make such a nomination within the time specified in the notice.
- (3) If a nomination is not duly made within that time, the Chairperson is to determine the region in respect of which the banana grower is to vote (being a region in which a plantation is wholly or partly situated on which bananas are grown by or behalf of the banana grower). The Chairperson is to give notice of that determination to the banana grower as soon as practicable after it is made.
- (4) Once a nomination by, or determination with respect to, a banana grower is made under this section, it cannot be changed by further nomination or determination except in special circumstances approved by the Chairperson. For example, the Chairperson may approve a banana grower changing the region in which he or she is entitled to vote because the banana grower is no longer a banana grower in relation to a plantation situated in the region previously nominated.

## 16D Voting entitlements of regional banana growers in election

- (1) A banana grower who is entitled to vote in an election is entitled to cast a vote or votes in the election according to the area of the plantation on which bananas are grown by or on behalf of the banana grower, as follows:
  - (a) if the area of the plantation exceeds the minimum area but does not exceed 4 hectares—1 vote,

A person is not entitled to vote in an election if the person has not paid all charges, fees and other amounts due and payable to the Committee under this Act in respect of the financial year last preceding the election by the close of enrolments for the election under the regulations.

#### 16G List of regional banana growers

For the purposes of an election, the Minister is to cause a list to be compiled, in accordance with the regulations, of banana growers entitled to vote in the election and the number of votes those banana growers are entitled to cast in the election.

(2) A person who ceases to hold office by virtue of this clause is not entitled to any remuneration or compensation in respect of ceasing to hold office but is eligible (if otherwise qualified) for re-appointment or election to the Committee.

# 13 Directors of Federation to continue to act as members of Committee until regional members are elected

- (1) This clause applies if, on the commencement of the amendment to section 3 made by the amending Act, no regional members have been elected to hold office as members of the Committee in accordance with Part 4A.

  - each of the first regional members elected to hold (a) office on the Committee pursuant to section 3 (as amended by the amending Act), and
  - any regional member of the Committee who is (b) elected pursuant to section 3A (2) (following a change in the boundaries of the regions to be 10 represented on the Committee).
- (2) A regional member holds office, despite clause 1 (2) of Schedule 1 but subject to the other provisions of that Schedule, for the period specified by the Minister in that determination commencing on the date of election of the member.
- The Minister is not required to specify the same term of (3)office for each regional member but in any case the term of office must not be less than 1 year nor more than 4 years.
- A determination under this clause with respect to a (4)regional member cannot be varied by a further determination.

#### 15 Chairperson of Committee

(1) The member of the Committee who, immediately before 25 the commencement of the amendment to section 3 made by the amending Act, held office as Chairperson of the Committee, ceases to hold office as Chairperson on the commencement of that amendment or, if no regional members have been elected to hold office on the Committee by that commencement, on the election of the first regional members of the Committee.



## Banana Industry Amendment Act 1996 No 59

Act No 59, 1996

An Act to amend the *Banana Industry Act 1987* to reconstitute the Banana Industry Committee; to amend the voting entitlements of banana growers; and for other purposes. [Assented to 19 September 1996]

#### The Legislature of New South Wales enacts:

#### 1 Name of Act

This Act is the Banana Industry Amendment Act 1996.

#### 2 Commencement

This Act commences on a day or days to be appointed by proclamation.

#### 3 Amendment of Banana Industry Act 1987 No 66

The Banana Industry Act 1987 is amended as set out in Schedule 1.

#### Schedule 1 Amendments

(Section 3)

#### [1] Section 2 Definitions

Insert "or an official publication of the Committee" after "Federation" in the definition of *advertisement* in section 2 (1).

#### [2] Section 2 (1)

Insert in alphabetical order:

*election* means an election of a regional member of the Committee.

region means a region of the banana industry to be represented on the Committee.

regional member means a member of the Committee who represents a region.

#### [3] Section 3 The Committee

Omit section 3 (3). Insert instead:

- (3) The Committee is to consist of:
  - (a) 2 persons appointed by the Minister, and
  - (b) regional members.

#### [4] Section 3A

Insert after section 3:

#### 3A Regions to be represented on Committee

- (1) The Minister may from time to time, on the recommendation of the Committee, by order published in the Gazette determine:
  - (a) the number of regions of the banana industry that are to be represented on the Committee, and
  - (b) the boundaries of those regions.

- (2) If at any time after the first determination is made under this section, a further determination is made that changes the boundaries of any of the regions:
  - (a) an election of members to represent the regions so changed is required to be held in accordance with the regulations, and
  - (b) each of the regional members holding office in respect of a region so changed ceases to hold office on the election of the new regional members.
- (3) A regional member who ceases to hold office by virtue of this section is not entitled to any remuneration or compensation in respect of ceasing to hold office but is eligible (if otherwise qualified) for re-election to the Committee.

#### [5] Section 5 Functions of Committee

Insert after section 5 (o):

(o1) support, with or without grant of financial aid and whether or not initiated by the Committee, any group or body that assists the Committee in the exercise of the Committee's functions under this Act,

Insert at the end of section 9 (7): Maximum penalty: 20 penalty units.

#### [7] Section 11 Power to require information

Insert at the end of section 11 (3): Maximum penalty: 20 penalty units.

#### [8] Section 12 List of banana growers

Omit subsections (1)-(4). Insert instead:

- (1) For the purposes of a poll, the Minister is to cause a list to be compiled, in accordance with the regulations, of banana growers who are entitled to vote in a poll and of the number of votes those banana growers are entitled to cast in the poll.
- (2) If, after application made in accordance with the regulations for the purpose, a person is not satisfied with the result of the application, that person may apply as prescribed to a Local Court for an order that the name of the person or a particular voting entitlement for the person be included in the list.
- (3) The Local Court has the jurisdiction to hear and determine the matter of the application and may:
  - (a) order that the name of the applicant be included in the list or that a particular voting entitlement for the person be included in the list, or
  - (b) dismiss the application.
- (4) If an order is made under subsection (3) (a), the list is to be changed in the manner necessary to give effect to the order.

#### 12A Voting entitlements of banana growers in poll

(1) A banana grower who is entitled to vote in a poll is entitled to cast a vote or votes at a poll according to the area of the plantation on which bananas are grown by or on behalf of the banana grower, as follows:

- (a) if the area of the plantation exceeds the minimum area but does not exceed 4 hectares—1 vote,
- (b) if the area of the plantation exceeds 4 hectares but does not exceed 8 hectares—2 votes,
- (c) if the area of the plantation exceeds 8 hectares—3 votes.
- (2) If bananas are grown by or on behalf of a banana grower on more than one plantation (whether or not in the same region), the number of votes the banana grower may cast is to be determined by reference to the total area of all plantations on which bananas are grown by or on behalf of the banana grower.
- (3) However, if there is more than one banana grower in relation to a plantation, the regulations may provide for the entitlement of those banana growers to vote and the number of votes (if any) that may be cast by each banana grower. A banana grower's entitlement to vote and the determination of the number of votes that the banana grower may cast in a poll is subject to any such regulations.
- (4) The maximum number of votes that may be cast by a banana grower in a poll (whether or not bananas are grown by or on behalf of the banana grower on more than one plantation) is 3 votes.
- (5) In this section:

**minimum area**, in relation to a plantation, means the minimum area prescribed for the purposes of paragraph (b) of the definition of **plantation** in section 2 (1) or, if no minimum area is prescribed, 0.5 hectares.

#### [11] Section 14 Poll for dissolution of Committee

Omit paragraph (d). Insert instead:

(d) is not to be taken unless the Committee has first made provision, in accordance with the regulations, for the costs and expenses of the poll.

### [12] Section 15

Omit the section. Insert instead:

## 15 One banana grower to vote per plantation

- (1) For the purposes of a poll, if 2 or more persons are banana growers in relation to one plantation:
  - (a) only one of them is entitled to vote in respect of that plantation in the poll, and
  - (b) both or all of them may, by agreement, nominate in writing addressed to the Chairperson which of them is entitled to vote, and
  - (c) if a nomination is not made under paragraph (b), the Chairperson is to determine the person who is entitled to vote
- (2) If a person is a banana grower in relation to more than one plantation, this section is subject to any regulations under section 12A. For example, the regulations may provide that if 2 or more persons are banana growers in relation to more than one plantation, only one of them is entitled to vote in the poll in respect of all or any of those plantations.

## [13] Section 15A

Insert after section 15:

# 15A Banana grower must be fully paid up to be entitled to vote in poll

A person is not entitled to vote in a poll if the person has not paid all charges, fees and other amounts due and payable to the Committee under this Act in respect of the financial year last preceding the poll by the close of enrolments for the poll under the regulations.

Omit the section.

## [15] Part 4A

Insert after Part 4:

# Part 4A Election of regional members of Committee 16A Regional members to be elected

- (1) A regional member is to be elected, in accordance with the regulations, by banana growers who are entitled to vote in the election for the region concerned.
- (2) One regional member is to represent each region.
- (3) The regulations may make provision for or with respect to the persons who are entitled to be nominated as candidates for election as regional members. A person's nomination is invalid if the person is not entitled to be so nominated.

## 16B Banana growers who are entitled to vote in election

- (1) Subject to this Part, a banana grower is entitled to vote in the election of a regional member if bananas are grown by or on behalf of the banana grower on a plantation that is situated within the region concerned.
- (2) If bananas are grown by or on behalf of a banana grower on plantations that are situated in different regions or on a plantation that is situated partly in one region and partly in another region, the banana grower is entitled to vote in an election in respect of one region only. That region is to be the region duly nominated by the banana grower or determined by the Chairperson under section 16C.

#### 16C Nomination of region

- (1) A banana grower who is otherwise entitled to vote in an election may at any time, by notice in writing given to the Chairperson, nominate the region in respect of which he or she intends to vote. The nomination is not valid unless the banana grower is a banana grower in relation to a plantation that is wholly or partly situated in that region.
- (2) The Chairperson may at any time, by notice in writing to a banana grower, require the banana grower to make such a nomination within the time specified in the notice.
- (3) If a nomination is not duly made within that time, the Chairperson is to determine the region in respect of which the banana grower is to vote (being a region in which a plantation is wholly or partly situated on which bananas are grown by or behalf of the banana grower). The Chairperson is to give notice of that determination to the banana grower as soon as practicable after it is made.
- (4) Once a nomination by, or determination with respect to, a banana grower is made under this section, it cannot be changed by further nomination or determination except in special circumstances approved by the Chairperson. For example, the Chairperson may approve a banana grower changing the region in which he or she is entitled to vote because the banana grower is no longer a banana grower in relation to a plantation situated in the region previously nominated.

# 16D Voting entitlements of regional banana growers in election

- (1) A banana grower who is entitled to vote in an election is entitled to cast a vote or votes in the election according to the area of the plantation on which bananas are grown by or on behalf of the banana grower, as follows:
  - (a) if the area of the plantation exceeds the minimum area but does not exceed 4 hectares—1 vote,

- (b) if the area of the plantation exceeds 4 hectares but does not exceed 8 hectares—2 votes,
- (c) if the area of the plantation exceeds 8 hectares—3 votes.
- (2) If bananas are grown by or on behalf of a banana grower on more than one plantation (whether or not in the same region), the number of votes the banana grower may cast is to be determined by reference to the total area of all plantations on which bananas are grown by or on behalf of the banana grower.
- (3) However, if there is more than one banana grower in relation to a plantation, the regulations may provide for the entitlement of those banana growers to vote and the number of votes (if any) that may be cast by each banana grower. A banana grower's entitlement to vote and the determination of the number of votes that the banana grower may cast in an election is subject to any such regulations.
- (4) The maximum number of votes that may be cast by a banana grower in an election (whether or not bananas are grown by or on behalf of the banana grower on more than one plantation) is 3 votes.
- (5) In this section:

minimum area has the same meaning as in section 12A.

## 16E One banana grower to vote per plantation

- (1) For the purposes of an election, if 2 or more persons are banana growers in relation to one plantation:
  - (a) only one of them is entitled to vote in respect of that plantation in the election, and
  - (b) both or all of them may, by agreement, nominate in writing addressed to the Chairperson which of them is entitled to vote, and
  - (c) if a nomination is not made under paragraph (b), the Chairperson is to determine the person who is entitled to vote.

(2) If a person is a banana grower in relation to more than one plantation, this section is subject to any regulations under section 16D. For example, the regulations may provide that if 2 or more persons are banana growers in relation to more than one plantation, only one of them is entitled to vote in the election in respect of all or any of those plantations.

# 16F Banana grower must be fully paid up to be entitled to vote in election

A person is not entitled to vote in an election if the person has not paid all charges, fees and other amounts due and payable to the Committee under this Act in respect of the financial year last preceding the election by the close of enrolments for the election under the regulations.

### 16G List of regional banana growers

- (1) For the purposes of an election, the Minister is to cause a list to be compiled, in accordance with the regulations, of banana growers entitled to vote in the election and the number of votes those banana growers are entitled to cast in the election.
- (2) The regulations may:
  - (a) provide that it is compulsory for a banana grower, or a banana grower of a prescribed description, to apply for enrolment in the list compiled under this section for an election, and
  - (b) provide that it is compulsory for a banana grower enrolled in the list compiled under this section for an election to vote in the election, and
  - (c) impose a penalty not exceeding 0.1 penalty unit for contravention of such a provision.
- (3) If, after application made in accordance with the regulations for the purpose, a person is not satisfied with the result of the application, that person may apply as prescribed to a Local Court for an order that the name of the person or a particular voting entitlement for the person be included in the list.

- (4) The Local Court has the jurisdiction to hear and determine the matter of the application and may:
  - (a) order that the name of the applicant be included in the list or that a particular voting entitlement for the person be included in the list, or
  - (b) dismiss the application.
- (5) If an order is made under subsection (4) (a), the list is to be changed in the manner necessary to give effect to the order.

## 16H False voting

If the name of a person does not appear on the list compiled under section 16G for an election and the person votes at the election, the person is guilty of an offence against this Act.

Maximum penalty: 20 penalty units.

#### 16l Failure of election

If no candidates are duly nominated for election as a regional member, or if an election fails for any other reason, the Minister may appoint a person nominated by the Committee to be a member of the Committee and a person so appointed is taken to be a person elected as a regional member in accordance with the regulations.

Any matter or thing done or omitted to be done by the Committee, any member of the Committee or any person acting under the direction of the Committee does not, if the matter or thing was done or omitted to be done in good faith for the purposes of executing this or any other Act, subject a member or a person so acting personally to any action, liability, claim or demand.

- (5) A person acting as a member of the Committee under this clause ceases to hold office when the first regional members are elected to hold office on the Committee in accordance with Part 4A.

  - (a) each of the first regional members elected to hold office on the Committee pursuant to section 3 (as amended by the amending Act), and
  - (b) any regional member of the Committee who is elected pursuant to section 3A (2) (following a change in the boundaries of the regions to be represented on the Committee).
- (2) A regional member holds office, despite clause 1 (2) of Schedule 1 but subject to the other provisions of that Schedule, for the period specified by the Minister in that determination commencing on the date of election of the member.
- (3) The Minister is not required to specify the same term of office for each regional member but in any case the term of office must not be less than 1 year nor more than 4 years.
- (4) A determination under this clause with respect to a regional member cannot be varied by a further determination.

## 15 Chairperson of Committee
