### Overview of Bill


The object of this Bill is to enable Cudgegong (Abattoir) County Council to give security for loans by way of a mortgage over its land.

# Outline of provisions

Clause 1 sets out the name (also called the short title) of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent.

Clause 3 is a formal provision giving effect to the amendment to the *Local Government Act 1993* set out in Schedule 1. Schedule 1 contains the amendment to the *Local Government Act 1993* described above.





- (2) This section has effect despite anything to the contrary in any provision of this Act applying to county councils by the operation of section 400.


