An Act to consolidate certain Acts for the raising and application of Public Loans. Assented to, 24th November, 1857.

THEREAS it is expedient to consolidate certain Acts relating to Preamble. the raising of Public Loans and to authorize the application of such Loans to the purposes of the said Acts generally Be it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of

the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. The Acts of Council seventeenth Victoria numbers thirty-four Acts 17 Vic. Nos. 34 and thirty-five eighteenth Victoria numbers thirty and thirty-five and 35—18 Vic. Nos. 38—nineteenth Victoria number thirty-eight except as hereinafter excepted 20 Vic. Nos. 1 16 20 and the Acts of the Parliament of New South Wales twentieth Victoria 33 34 Consolidated with this Act. numbers one sixteen twenty thirty-three and thirty-four shall be consolidated and shall together with and subject to the provisions of this Act be read and construed as one Act And all the powers and authorities of the said several Acts applicable to the purposes thereof respectively shall be deemed to be included in and to form part of this Act for the purposes and subject to the provisions hereof.

2. All moneys to be borrowed under any provisions of the said Loans already autho-Acts shall be deemed to be borrowed as under this Act Provided that rized applicable generally to purposes they shall be applied to the purposes of the said several Acts as therein of existing Acts. directed in such proportions as the Governor with the advice of the Executive Council shall from time to time by warrant or other writing under his hand and addressed to the Colonial Treasurer order and direct anything in the said Acts or in the Acts of Council eighteenth Victoria numbers thirty-four and thirty-six and nineteenth Victoria numbers forty and forty-two or in the Act of the said Parliament twentieth Victoria number forty or in any other Act to the contrary notwithstanding Provided also that nothing contained in this Act shall authorise the appropriation to any of the works or services set forth in the said Acts of any larger sum than is therein appropriated for any such work or service

Provided also that the accounts of all moneys so borrowed and of the several purposes to which the same shall be applied shall annually be laid before both Houses of the said Parliament and shall be examinable in like manner as moneys forming part of the Current Annual Revenue
