To alter and extend the Powers of the "Municipal Council of the City of Sydney."

WHEREAS by an Act of Council passed in the twentieth year of the Preamble. reign of Her present Majesty Queen Victoria and numbered thirty-six certain powers and authorities were given to the Municipal Council of Sydney and it is expedient to alter and extend the same Be it therefore 5 enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—
