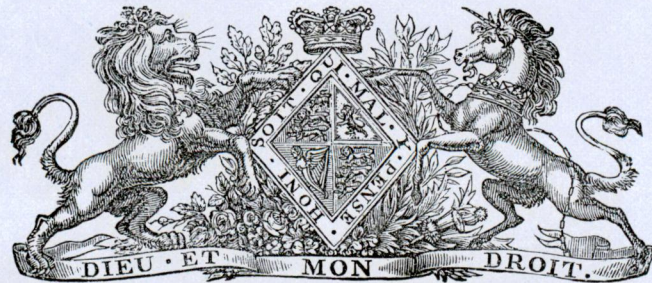

An Act to Indemnify the Government as to certain Payments for the Public Service.

WHEREAS during the month of March one thousand eight hundred and sixty divers sums of money amounting in the whole to eighty-four thousand seven hundred and twenty-one pounds twelve shillings and one penny sterling have without authority of Parliament been paid out of the Consolidated Revenue Fund for the expenses during the said period of the various Establishments throughout the Colony with a view to the efficient maintenance of such Establishments And whereas under the special circumstances of the case it is expedient that all Officers concerned in such expenditure should be indemnified in respect thereof Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows :—

1. His Excellency the Governor the Colonial Treasurer and all other Members of the Executive Council and the Auditor General having given or made or caused to be given or made any Warrant Order or Direction for the expenditure of such sum as aforesaid or any portion thereof and all persons whosoever having acted thereunder respectively are hereby indemnified for every such Warrant Order or Direction and for all payments made or caused to be made by them respectively during the said period for the services aforesaid not exceeding in the whole the said sum of eighty-four thousand seven hundred and twenty-one pounds twelve shillings and one penny sterling.

2. This Act shall be styled and may be cited as the "Government Indemnity Act of 1860."

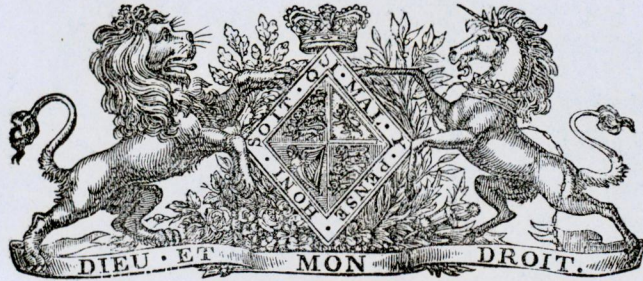
