HEREAS we Your Majesty's most dutiful and loyal subjects the Preamble. Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to your Majesty for the service of the year one thousand eight hundred and sixty the sum first 5 hereinafter mentioned being the amount of the Supplementary Estimate for that year and also on account for the year one thousand eight hundred and sixty-one the sum secondly hereinafter mentioned being the sum required to defray the expenses of the various Departments and Services of the Colony from first January to thirty-first March one 10 thousand eight hundred and sixty-one at the rates which have been sanctioned for the year one thousand eight hundred and sixty And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the two several sums so granted to Your Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by 15 and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

The Treasurer shall in his accounts from time to time be allowed credit for all sums of money paid by him in pursuance of such Warrants or Orders And the receipts of the respective persons to whom the same shall be so paid shall be full and valid discharges to the said Treasurer in passing his said accounts for such sums as shall be therein mentioned and he shall receive credit for the same accordingly.
