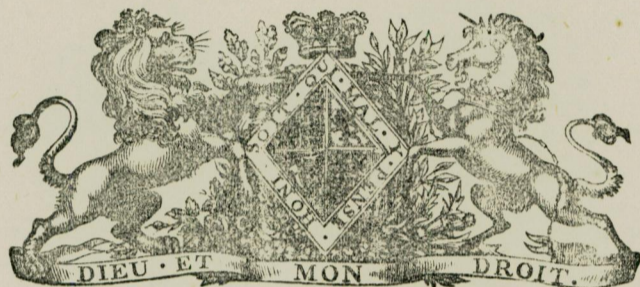

An Act to apply certain sums out of the Consolidated Revenue Fund of New South Wales towards the service of the year 1866.

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Two hundred and eight thousand eight hundred and ninety-
5 seven pounds fourteen shillings and nine-pence being the sum required to defray the expenses of the various Departments and Services of the Colony from first January to twenty-eighth February one thousand eight hundred and sixty-six And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum
10 so granted to Your Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales
15 there shall and may be issued and applied for or towards making good the supplies so resolved to be granted to Her Majesty for the service of the first two months of the year one thousand eight hundred and sixty-six commencing on the first day of January and ending on the twenty-eighth day of February in the said year the sum of Two hundred
20 and eight thousand eight hundred and ninety-seven pounds fourteen shillings and nine-pence.

2. The Treasurer shall issue and pay the said sum for the services aforesaid in such manner and in such proportions as the Governor by Warrants or Orders in writing under his hand and directed to the said Treasurer shall from time to time order and direct

Treasurer to pay under Governor's Warrant or Order.

5 And the payments so to be made shall be charged upon and payable out of the Consolidated Revenue Fund of the Colony.

3. The Treasurer shall in his accounts from time to time be allowed credit for all sums of money paid by him in pursuance of such Warrants or Orders And the receipts of the respective persons to

Treasurer to have credit and receipts to discharge him.

10 whom the same shall be so paid shall be full and valid discharges to the said Treasurer in passing his said accounts for such sums as shall be therein mentioned and he shall receive credit for the same accordingly.
