An Act to apply certain sums out of the Consolidated Revenue Fund of New South Wales towards the Service of the Year 1868.

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Two hundred and twenty-eight thousand two hundred and **5** eighteen pounds six shillings and ten-pence being the sum required to defray the expenses of the various Departments and Services of the Colony from first January to twenty-ninth February one thousand eight hundred and sixty-eight And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum **10** so granted to Your Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

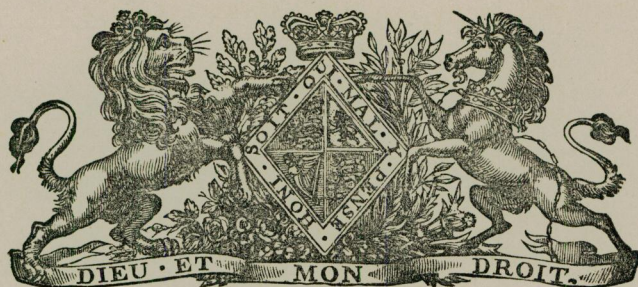

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Two hundred and twenty-eight thousand two hundred and eighteen pounds six shillings and ten-pence being the sum required to defray the expenses of the various Departments and Services of the Colony from first January to twenty-ninth February one thousand eight hundred and sixty-eight And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Your Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales there shall and may be issued and applied for or towards making good the supplies so resolved to be granted to Her Majesty for the service of the first two months of the year one thousand eight hundred and sixty-eight commencing on the first day of January and ending on the twenty-ninth day of February in the said year the sum of Two hundred and twenty-eight thousand two hundred and eighteen pounds six shillings and ten pence.
