An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Service of the Year 1870. [Assented to, 3rd February, 1870.]

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of One hundred and twenty-four thousand pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from first to thirty-first of January one thousand eight hundred and seventy And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sums so granted to your Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows :—

1. Out of the Consolidated Revenue Fund of New South Wales there shall and may be issued and applied for or towards making good the supplies so resolved to be granted to Her Majesty for the service of the month of January in the year one thousand eight hundred and seventy the sum of one hundred and twenty-four thousand pounds. £124,000 may be applied for January 1870.

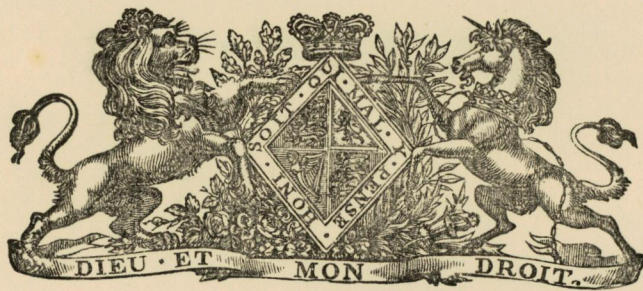
