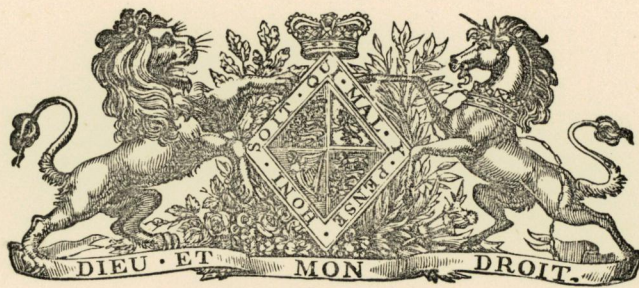

**W**HEREAS we Your Majesty's most dutiful and loyal subjects Preamble.  
the Members of the Legislative Assembly of New South Wales  
in Parliament assembled have resolved to grant to Your Majesty the  
sum of One hundred and twenty-five thousand three hundred pounds  
5 being the sum required to defray the expenses of the various Depart-  
ments and Services of the Colony from first to thirty-first January one  
thousand eight hundred and seventy-one And whereas we desire to  
make good out of the Consolidated Revenue Fund of New South Wales  
the sums so granted to your Majesty Be it therefore enacted by the  
10 Queen's Most Excellent Majesty by and with the advice and consent  
of the Legislative Council and Legislative Assembly of New South  
Wales in Parliament assembled and by the authority of the same as  
follows :—

1. Out of the Consolidated Revenue Fund of New South Wales £125,300 may be applied for January 1871.

of the month of January in the year one thousand eight hundred and  
seventy-one the sum of one hundred and twenty-five thousand three  
hundred pounds.

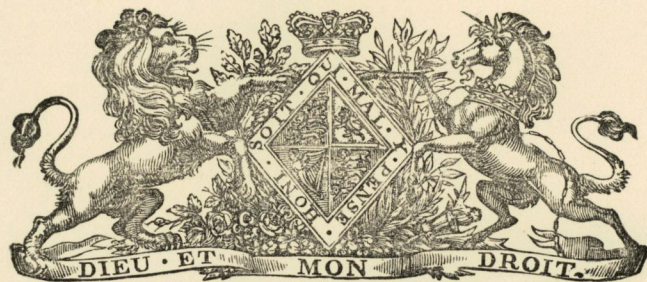

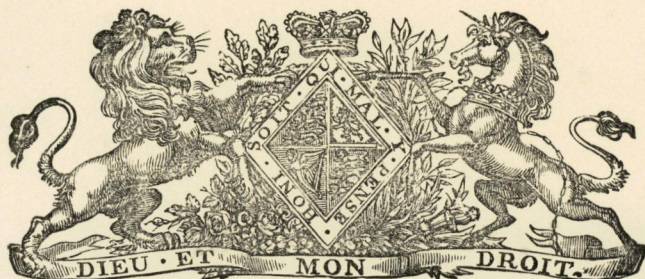
