An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Service of the Year 1871.

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales
in Parliament assembled have resolved to grant to Your Majesty the
sum of One hundred and twenty-five thousand three hundred pounds
5 being the sum required to defray the expenses of the various Depart-
ments and Services of the Colony from the first to the thirtieth of April
one thousand eight hundred and seventy-one And whereas we desire
to make good out of the Consolidated Revenue Fund of New South
Wales the sum so granted to Her Majesty Be it therefore enacted by

South Wales in Parliament assembled and by the authority of the

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Service of the Year 1871. [Assented to, 29th April, 1871.]

WHEREAS we Your Majesty's most dutiful and loyal subjects ^{Preamble.} the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of One hundred and twenty-five thousand three hundred pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from the first to the thirtieth of April one thousand eight hundred and seventy-one And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales ^{£125,300 may be issued out of the Consolidated Revenue Fund.} there shall and may be issued and applied for or towards making good the supplies so resolved to be granted to Her Majesty for the services of the month of April in the year one thousand eight hundred and seventy-one the sum of One hundred and twenty-five thousand three hundred pounds to be expended at the rates which have been sanctioned for the year one thousand eight hundred and seventy subject to the rate of any reduction that may hereafter be made in the expenditure of the year one thousand eight hundred and seventy-one.

3. The Treasurer shall in his accounts from time to time be allowed credit for all sums of money paid by him in pursuance of such Warrants or Orders And the receipts of the respective persons to whom the same shall be so paid shall be full and valid discharges to the said Treasurer in passing his said accounts for such sums as shall be therein mentioned and he shall receive credit for the same accordingly.
