An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Service of the Year 1871.

**W**HEREAS we Your Majesty's most dutiful and loyal subjects the Preamble.  
Members of the Legislative Assembly of New South Wales  
in Parliament assembled have resolved to grant to Your Majesty the  
sum of One hundred and twenty-five thousand three hundred pounds  
5 being the sum required to defray the expenses of the various Depart-  
ments and Services of the Colony from the first to the thirty-first of  
May one thousand eight hundred and seventy-one And whereas we  
desire to make good out of the Consolidated Revenue Fund of New  
South Wales the sum so granted to Her Majesty Be it therefore  
10 enacted by the Queen's Most Excellent Majesty by and with the advice  
and consent of the Legislative Council and Legislative Assembly of  
New South Wales in Parliament assembled and by the authority of  
the same as follows :—

1. Out of the Consolidated Revenue Fund of New South Wales £125,300 may be issued out of the Consolidated Revenue Fund.

WHEREAS we Your Majesty's most dutiful and loyal subjects the Preamble. Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of One hundred and twenty-five thousand three hundred pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from the first to the thirty-first of May one thousand eight hundred and seventy-one And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows :—

1. Out of the Consolidated Revenue Fund of New South Wales there shall and may be issued and applied for or towards making good the supplies so resolved to be granted to Her Majesty for the services of the month of May in the year one thousand eight hundred and seventy-one the sum of One hundred and twenty-five thousand three hundred £125,300 may be issued out of the Consolidated Revenue Fund.
