The present and all future Trustees of the said lands shall out Trustees to pay £150 50 of the annual rents issues and profits to be received by them in respect Maitland Church and of the said lands in the first place pay to the Minister of the said Church #150 to Minister of West Maitland at East Maitland aforesaid the sum of one hundred and fifty pounds or Church. such part thereof as the amount of the said annual rents issues and profits shall allow and in the next place pay to the Minister of the said
