It shall be lawful for the said James Williamson and Isaac Aaron or the survivor of them or other the Trustees or Trustee for the time-being of the said grant instead of applying the said moneys which shall be so paid into the hands of the said Colonial Treasurer as hereinbefore mentioned in the purchase of other land as hereinbefore mentioned to apply the same in assisting the Trustees for the timebeing of the said land Chapel and buildings in Macquarie-street aforesaid either to enlarge the said Chapel and buildings now standing and being on the said land or to erect and build a new Chapel and School on the said land.

6. The drafts of the Trustees for the time-being of the said grant or of the majority of them shall be a sufficient discharge to the said Colonial Treasurer for all sum or sums of money which shall be therein expressed to be drawn for and as shall have been paid in pursuance thereof and the said Colonial Treasurer shall not be responsible in respect of any misapplication or non-application of any money so paid by him on any such draft.
