WHEREAS it is expedient to repeal from and after the first day of Preamble. January one thousand eight hundred and seventy-four so much of the "Customs Duties Act of 1871" as provides for the imposition and collection of *ad valorem* duties and to abolish the specific duties 5 on some of the articles specified in Schedule B to the said Act And whereas it is expedient to impose the additional specific duty hereinafter mentioned from and after the aforesaid date Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly 10 of New South Wales in Parliament assembled and by the authority of the same as follows :-


