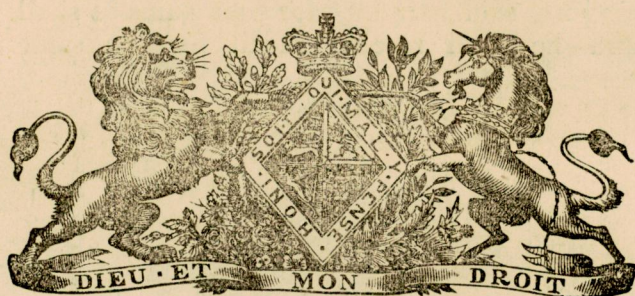

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Year 1877.

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble.
the Members of the Legislative Assembly of New South Wales
in Parliament assembled have resolved to grant to Your Majesty the
sum of Two hundred and forty-two thousand five hundred pounds being

whereas we desire to make good out of the Consolidated Revenue
Fund of New South Wales the sum so granted to Her Majesty Be it

authority of the same as follows:—

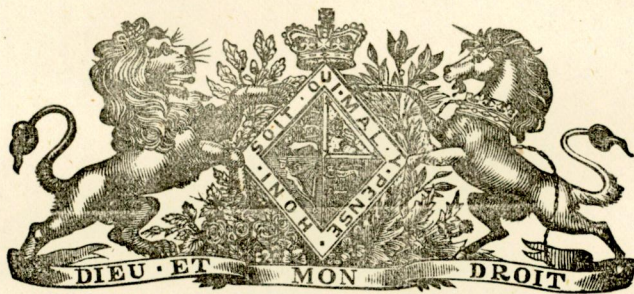

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Year 1877. [Assented to, 1st March, 1877.]

WHEREAS we Your Majesty's most dutiful and loyal subjects ^{Preamble.} the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Two hundred and forty-two thousand five hundred pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from the first to the twenty-eighth February one thousand eight hundred and seventy-seven And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales ^{£242,500 may be issued out of the Consolidated Revenue Fund.} there shall and may be issued and applied for or towards making good the supply so resolved to be granted to Her Majesty for the service of the month of February in the year one thousand eight hundred and
