
This Public Bill originated in the Legislative Assembly, and, having this day passed, is now ready for presentation to the Legislative Council for its concurrence.

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Year 1877.

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble. the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Two hundred and seventy-three thousand five hundred pounds 5 that is to say—

The sum of Two hundred and forty-two thousand five hundred pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from first to thirty-first July one thousand eight hundred and seventy-seven and

The sum of Thirty-one thousand pounds for services of the year one thousand eight hundred and seventy-seven as set forth in the Schedule hereto annexed

And whereas we desire to make good out of the Consolidated Revenue 15 Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with
