The said Council may from time to time make by-laws for regulating the said sale-yards and for determining the fees and charges so to be paid as aforesaid and the times and modes of collecting and enforcing payment thereof and all the provisions of the "Municipalities Act of 1867" relating to the making and confirmation of bylaws made thereunder and the proof and enforcement of such by-laws shall apply to all by-laws made under this Act as fully and effectually as if such provisions were incorporated herewith.

5. This Act shall come into operation immediately upon passing and may be cited as "The Goulburn Cattle Sale-yards Act of 1875."
