An Act to subdivide the Electoral District of The Hastings.

B it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows :—

2. From and after the passing of this Act the Electoral District Subdivision of of the Hastings as constituted by the "Electoral Act of 1858" hereininto two Electoral after termed the Principal Act shall be divided into two Electoral Districts.

5. For every subsequent election an Electoral Roll for each of Electoral Roll for the said Electoral Districts of the Macleay and Port Macquarie and the said districts.

30 Manning shall be made and revised in accordance with the provisions of the said Principal Act amended as hereinbefore described and each such Roll after revision shall be the Electoral Roll for each of the said Electoral Districts for the purpose of every General Election of Members to serve in the said Assembly and also in the case of any vacancy of

THE MACLEAY AND PORT MACQUARIE.

Embracing the Pastoral District of Macleay and the northern portion of the County of Macquarie and bounded on the north by the boundary dividing the Pastoral District of 5 Macleay and Clarence being a line west from the sea near the Solitary Islands to the range forming the southern watershed of the Clarence River and that range westerly to the eastern boundary of the Pastoral District of New England on the west by part of that boundary being the fall of the eastern extreme of the Tableland of New England southerly to Mount Werrikimbe thence by a line southerly to Mount Sea-view and thence 10 by a line south-westerly to the range dividing the waters of the Hastings and Manning Rivers at a point in a line from Mount Sea-view to the confluence of the Manning and Barnard Rivers on the south by that range easterly and by the range from that range Barnard Rivers on the south by that range easterly and by the range from that range dividing the waters of Queen's and Watson Taylor's Lakes to the North Brother Mountain and thence by a line easterly to Camden Haven and on the east by the sea northerly to 15 the point of commencement.

THE MANNING.

Embracing a southern portion of the County of Macquarie and a north-eastern portion of the County of Gloucester and bounded on the north from Camden Haven by a line westerly to North Brother Mountain and by the range dividing the waters of Queen's 20 and Watson Taylor's Lakes and the range dividing the waters of the Manning and Hastings Rivers westerly to its intersection with a line from Mount Sea-view to the confluence of the Manning and Barnard Rivers on the west by that line south-westerly to that confluence and by the Manning River downwards to the confluence of the Gloucester River and thence by the eastern watershed of the Gloucester River southerly to the range 25 dividing the waters falling to The Broadwater and Myall Lake from those falling to the Wollomba and Maclean Rivers and Wallis Lake near the source of the Myall River on the Wollomba and Maclean Rivers and Wallis Lake near the source of the Myall River on the south by the last-mentioned range easterly and the spur range from that range passing between Myall and Smith's Lakes easterly to Sugar-loaf Point and on the east by the sea northerly to Camden Haven aforesaid.
