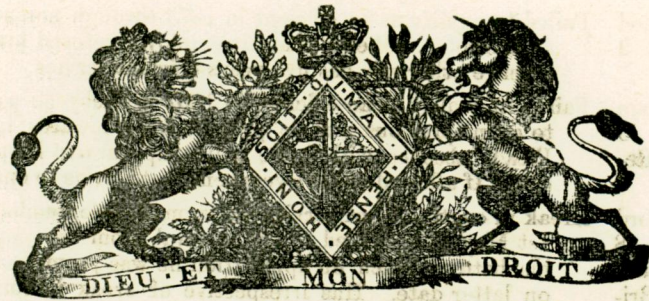

An Act to authorize the issue in certain specified cases of Certificates to Members of the Volunteer Force entitling them to Grants of Land under the Act 31 Victoria No. 5.

WHEREAS the persons named in the Schedule to this Act would ^{Preamble.} but for the occurrence of circumstances hereinafter mentioned have been entitled to receive certificates of efficiency under the "Volunteer Force Regulation Act of 1867" (being the Act thirty-one 5 Victoria number five) and the Regulations thereunder to the effect that the persons therein named had each served as an efficient Volunteer for the period prescribed by the said Act and which would have entitled such persons to free grants of land as in the said Act provided And whereas by reason of death disability unavoidable accident 10 misfortune or other like impediment not attributable to the neglect or other default of the persons themselves such certificates of efficiency cannot be lawfully granted to the persons so named as aforesaid and it is expedient to authorize the issue of such certificates in the cases specified in the said Schedule Be it therefore enacted by the Queen's 15 Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by authority of the same as follows:—

1. Certificates of efficiency within the meaning and for the purpose of the forty-fourth section of the said Act shall upon the 20 passing of this Act be issued in the names of the respective persons specified in the Schedule hereto by the officer commanding the Volunteer Force as if each such person had duly complied with the provisions

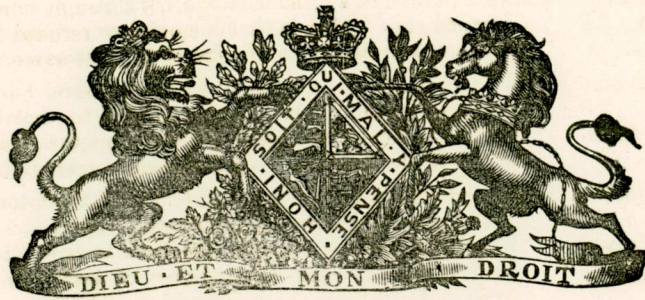

provisions of the said Volunteer Force Regulation Act and the Regulations made thereunder And every such certificate shall be of the same force and effect in law and for all purposes as if the same had been issued in the usual manner upon due compliance with the terms of the said Act and Regulations and shall in the event of the death of the Volunteer therein named be issued to his personal representative or to some person who shall appear to the Governor with the advice of the Executive Council to be rightfully entitled thereto.
