Within thirty days after the passing of this Act the sum of six hundred pounds being the sum originally agreed to be paid as purchase money for the said land and which said sum was appropriated by Parliament by the Appropriation Act forty-one Victoria number twenty-four for the purchase of the said parcel of land and therein directed to be paid to the said Council shall be paid by the Colonial Treasurer to the Council of the said borough or to such bankers corporation or other persons as may by writing under the hands of the Mayor and any two Aldermen of the said Borough and countersigned by the Council Clerk thereof be appointed to receive the same And the payment of the said sum by the said Treasurer in terms of this section shall be a full and complete discharge to him and to Her Majesty in respect of the said sum and the application thereof.
