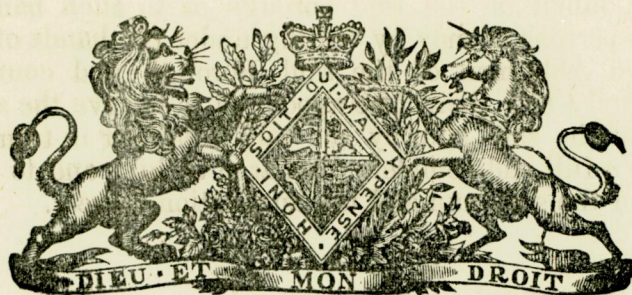

An Act to authorize the acquisition by Her Majesty of certain Buildings in the Borough of Waratah for the purposes of a Court House.

**W**HEREAS it is necessary that Legislative authority should be Preamble. obtained in order that the parcel of land described in the Schedule hereto together with the buildings thereon erected may be effectually vested in Her Majesty for the purposes of this Act freed and discharged from any trusts express implied or constructive which might be deemed to be annexed thereto and to indemnify the Council of the said Borough in respect of any breach of trust which they might be deemed to have committed in respect of the surrender of or the agreement to surrender the said parcel of land to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Upon the passing of this Act the parcel of land described in the Schedule hereto together with all buildings erected thereon shall for the purpose of being used as a Court House vest in Her Majesty her heirs and successors for an estate of fee simple of inheritance in possession freed and discharged from all trusts

whether express implied or constructive which might be deemed to be annexed to the Council of the Borough of Waratah or to any other persons in respect of such parcel of land And the said Council and persons are hereby indemnified in respect of any breach of trust which  
 5 they might be deemed to have committed in respect of the surrender or agreement to surrender hereinbefore referred to And all contracts agreements liabilities obligations rights-of-way and all other easements whatsoever heretofore incident to or which might be deemed to be a charge upon the said parcel of land whether at law or in equity are  
 10 hereby extinguished and annulled.

2. Within thirty days after the passing of this Act the sum of six hundred pounds being the sum originally agreed to be paid as purchase money for the said land and which said sum was appropriated by Parliament by the Appropriation Act forty-one Victoria number  
 15 twenty-four for the purchase of the said parcel of land and therein directed to be paid to the said Council shall be paid by the Colonial Treasurer to the Council of the said borough or to such bankers corporation or other persons as may by writing under the hands of the Mayor and any two Aldermen of the said Borough and counter-  
 20 signed by the Council Clerk thereof be appointed to receive the same And the payment of the said sum by the said Treasurer in terms of this section shall be a full and complete discharge to him and to Her Majesty in respect of the said sum and the application thereof.

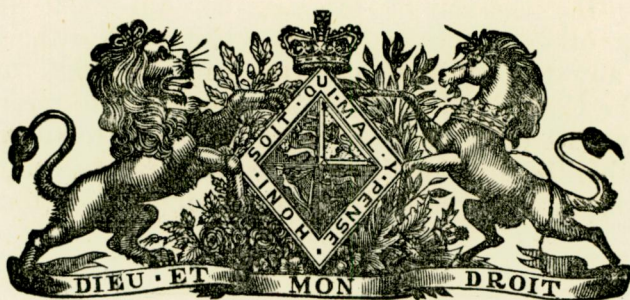

## SCHEDULE.

## No. IV.

An Act to authorize the acquisition by Her Majesty of certain Buildings in the Borough of Waratah for the purposes of a Court House. [Assented to, 15th July, 1879.]

**W**HEREAS it is necessary that Legislative authority should be Preamble. obtained in order that the parcel of land described in the Schedule hereto together with the buildings thereon erected may be effectually vested in Her Majesty for the purposes of this Act freed and discharged from any trusts express implied or constructive which might be deemed to be annexed thereto and to indemnify the Council of the said Borough in respect of any breach of trust which they might be deemed to have committed in respect of the surrender of or the agreement to surrender the said parcel of land to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Upon the passing of this Act the parcel of land described in the Schedule hereto together with all buildings erected thereon shall for the purpose of being used as a Court House vest in Her Majesty her heirs and successors for an estate of fee simple of inheritance in possession freed and discharged from all trusts Resumption of Waratah Council Chambers by Her Majesty. whether

whether express implied or constructive which might be deemed to be annexed to the Council of the Borough of Waratah or to any other persons in respect of such parcel of land And the said Council and persons are hereby indemnified in respect of any breach of trust which they might be deemed to have committed in respect of the surrender or agreement to surrender hereinbefore referred to And all contracts agreements liabilities obligations rights-of-way and all other easements whatsoever heretofore incident to or which might be deemed to be a charge upon the said parcel of land whether at law or in equity are hereby extinguished and annulled.

2. Within thirty days after the passing of this Act the sum of six hundred pounds being the sum originally agreed to be paid as purchase money for the said land and which said sum was appropriated by Parliament by the Appropriation Act forty-one Victoria number twenty-four for the purchase of the said parcel of land and therein directed to be paid to the said Council shall be paid by the Colonial Treasurer to the Council of the said borough or to such bankers corporation or other persons as may by writing under the hands of the Mayor and any two Aldermen of the said Borough and countersigned by the Council Clerk thereof be appointed to receive the same And the payment of the said sum by the said Treasurer in terms of this section shall be a full and complete discharge to him and to Her Majesty in respect of the said sum and the application thereof.

## SCHEDULE.

One acre county Northumberland parish of Newcastle at Waratah Commencing at the north-eastern corner of the two acres for a public school on the west by the eastern boundary-line of that land bearing southerly five chains on the south by a line bearing easterly two chains on the east by a line bearing northerly five chains and on the north by a line bearing west two chains to the point of commencement.
