This Public Bill originated in the Legislative Council, and, having this day passed, is now ready for presentation to the Legislative Assembly for its concurrence.

An Act to amend the Law respecting the Procedure and Practice of the Supreme Court in its Equitable Jurisdiction.

BE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

# 5 Jurisdiction of the Judge in Equity.

1. It shall be lawful for the Governor with the advice of the Appointment and Executive Council to appoint one of the Judges of the Supreme Court jurisdiction of Judges to be the Primary Judge in Equity hereinafter called the Judge and as such Judge to exercise the jurisdiction of the said Court in Equity 10 And the Supreme Court shall be holden by the Judge so appointed for the determination of all proceedings in Equity and all such other matters and the disposal of motions and matters in relation thereto respectively and every decree or order of the Judge made in Equity

or in any such other matter (unless appealed from in manner herein-15 after provided) shall be as valid and binding as if made by the full Court.

2. In case of the absence from Sydney or illness of the Judge Judge's absence or so appointed it shall be lawful for any of the other Judges (during illness. such absence or illness) to sit alone and determine all such matters as aforesaid in like manner as the Judge so being ill or absent might 5 have done but subject nevertheless to the like appeal.

3. Wherever in this Act the word "Court" is used it shall be The word "Court." taken to mean the Court holden before the Judge so appointed as aforesaid or the Judge acting under the last preceding section in his

stead unless the context shall require a different construction.

4. In any suit or proceeding in Equity wherein it may be Power to decide necessary to establish any legal title or right as a foundation for relief legal titles &c. the Court shall itself determine such title or right without requiring the parties to proceed at law to establish the same and whenever any question now cognizable only at law shall arise in the course of any

15 proceeding before him the Judge shall have cognizance thereof as completely as if the same had arisen in a Court of Law and shall exercise in relation to such title right or question all the powers of the Supreme Court in its Common Law Jurisdiction and no suit in Equity shall be open to objection on the ground that the remedy or

20 appropriate remedy is in some other jurisdiction.

5. In any cause or matter the Judge may sit with the assistance Judge or Judges of any two other Judges of the Supreme Court Provided always that assisting. in every such case where three Judges sit the decision of the majority

shall be taken to be that of the full Court. 25 6. After the passing of this Act it shall not be lawful for the Duties of the Judge to exercise any jurisdiction at the Common Law side of the Equity. Supreme Court Provided that it shall be lawful for the Governor with the advice of the Executive Council from time to time to authorize and direct the Judge to exercise Common Law jurisdiction whenever

30 the same may be deemed expedient And provided also that in case of the absence from Sydney of all the other Judges of the Supreme Court it shall be lawful for the Judge to exercise Common Law jurisdiction in the like manner as any one of the other Judges might have done had he been present in Sydney.

#### Statement of Claim.

7. After the commencement of this Act all persons seeking Form of initiatory equitable relief shall instead of proceeding by bill of complaint file in pleading. the office of the Master in Equity a statement of his case to be termed the statement of claim which shall contain as concisely as may be 40 a narrative of the material facts and circumstances on which the plaintiff relies but not the evidence by which they are to be proved such narrative being divided into paragraphs numbered consecutively and each paragraph containing as nearly as may be a separate and distinct statement or allegation and shall pray specifically for the relief which

45 the plaintiff may consider himself entitled to and also for general relief.

#### Parties.

8. It shall not be competent to any defendant to take any Rules as to parties. objection for want of parties in any case to which the rules next hereinafter set forth extend and such rules shall be taken as part of 50 the law and practice of the Court and any law or practice inconsistent therewith is hereby annulled.

Rule 1. Any legatee devisee or next of kin may without serving the remaining legatees devisees or next of kin have a decree for the administration of the real and personal estate of a

deceased person.

Rule 2. Any one of several cestui que trust under any deed or instrument may without serving any other of such cestui que trust have a decree for the execution of the trusts of the deed or instrument. Rule

Rule 3. In all cases of suits for the protection of property pending litigation and in all cases in the nature of waste one person may sue on behalf of himself and of all persons having the same interest.

Rule 4. Any executor administrator or trustee may obtain a decree against any one legatee next of kin or cestui que for the administration of the estate or the execution of the trusts.

Rule 5. In all the above cases the Court if it shall see fit may require any other person or persons to be made a party or parties to the suit and may if it shall see fit give the conduct of the suit to such person as it may deem proper and may make such order in any particular case as it may deem just for placing the defendant on the record on the same footing in regard to costs as other parties having a common interest

with him in the matters in question.

Rule 6. In all the above cases the persons who according to the present practice of the Court would be necessary parties to the suit shall be served with notice of the decree and after such notice they shall be bound by the proceedings in the same 20 manner as if they had been originally made parties to the suit and they may by an order of course have liberty to attend the proceedings under the decree and any party so served may within such time as shall in that behalf be prescribed by the general order of the Supreme Court apply to the Court to add 25 to the decree.

Rule 7. In all suits concerning real or personal estate which is vested in trustees under a will settlement or otherwise such trustees shall represent the persons beneficially interested under the trust in the same manner and to the same extent as the executors or administrators in suits concerning personal estate represent the persons beneficially interested in such personal estate and in such cases it shall not be necessary to make the persons beneficially interested under the trusts parties to the suit but the Court may upon consideration of the matter on the hearing if it shall so think fit order such

persons or any of them to be made parties.

9. If in any suit or proceeding in Equity it shall appear to the Absence of personal Court that any deceased person who was interested in the matters representatives in question has no legal personal representative it shall be lawful for 40 the Court either to proceed without any person representing the estate of such deceased person or to appoint some person to represent such estate for the purposes of the suit or proceeding on such notice (if any) as the Court shall think fit either specially or generally by public advertisement and every order made in reference to the matter and 45 every order consequent thereon shall bind the estate of such deceased person in the same manner as if there had been a duly constituted legal personal representative of such deceased person and such representative had been a party to the suit or proceeding and had appeared and submitted his rights and interests to the protection of the Court.

10. No suit shall be dismissed by reason only of the misjoinder Misjoinder of plainof persons as plaintiffs but wherever it shall appear to the Court tiffs that notwithstanding the conflict of interest in the co-plaintiffs or the want of interest in some of the plaintiffs or the existence of some ground of defence affecting some or one of the plaintiffs the 55 plaintiffs or some or one of them are or is entitled to relief the Court may grant such relief and modify its decree according to the special circumstances and for that purpose may direct such amendments if any as may be necessary and at the hearing before such amendments are made may treat any one or more of the plaintiffs as if he or they

was or were a defendant or defendants in the suit and the other plaintiff or plaintiffs was or were the only plaintiff or plaintiffs on the record and where there is a misjoinder of plaintiffs and the plaintiff having an interest has died leaving a plaintiff on the record without 5 an interest the Court may at the hearing order the cause to stand revived as may appear just and proceed to the decision of the cause if it shall see fit and may give such directions as to costs or otherwise as to the Court shall seem meet.

11. It shall be lawful for the Court to adjudicate on questions Absence of persons

20 be of opinion that the application is fradulent or collusive or for some other reason ought not to be entertained it may refuse to make the order prayed.

It shall not be necessary that every defendant to the state-Defendant not ment of claim shall be interested as to all the relief thereby prayed for interested as to all the Court may make such order as may appear just to prevent any defendant from being embarrassed or put to expense by being required to attend any proceedings in such suit in which he may have no interest.

13. Before the name of any person shall be used in any suit as As to next friend, &c. 30 next friend of any infant married woman or other party or as relator in any information such person shall sign a written authority to the solicitor for that purpose and such authority shall be filed with the statement of claim.

#### Service of Statement of Claim.

14. No writ of subpæna or other process to appear to and answer service of statement any statement of claim shall be required but the defendant shall be of claim. served with a written copy of such statement of claim according to the practice now in force respecting the service of bills of complaint together with an endorsement thereon in the form or to the effect set 40 out in the First Schedule to this Act with such variations as circumstances may require stamped with a proper stamp by one of the Clerks of the Supreme Court.

#### Copies of Statement of Claim.

16. The plaintiff in any suit in Equity instituted after the Delivering copies of commencement of this Act shall deliver to the defendant or his statement of claim. 50 solicitor upon application for the same such a number of copies of the statement of claim as he shall require upon being paid for the same at such rate as shall be prescribed by any general rule.

#### Amendment of Statement of Claim.

17. Upon the amendment of any statement of claim the pro-Proceedings upon 55 visions hereinbefore contained with respect to filing and serving and amendment. delivering copies thereof shall so far as may be extend to the statement of claim as amended Provided that where according to the present practice

22. A defendant may in his statement of defence set off or set Counter-claims by up by way of counter-claim against the claims of the plaintiff any right defendant. or claim and such set-off or counter-claim shall have the same effect as a statement of claim in a cross suit so as to enable the Court to pronounce a final judgment in the same suit both on the original and on the cross claim But the Court may on the application of the plaintiff before trial if in the opinion of the Judge such set-off or counter-claim cannot be conveniently disposed of in the pending suit or ought not to be allowed refuse permission to the defendant to avail himself thereof.

23. Where in any suit a set-off or counter-claim is made avail- Court may decree in able as a defence against the plaintiff's claim the Court may if the favor of defendant. balance is in favour of the defendant make a decree in favour of the defendant for such balance or may otherwise adjudge to the defendant 5 such relief as he may be entitled to upon the merits of the case.

## Defendant's Interrogatories.

24. Any defendant (but where he has been required to answer Discovery at instance interrogatories not until after he shall have put in a sufficient answer of a defendant. thereto) may in like manner by leave of the Court file interrogatories

10 for the examination of the plaintiff to which interrogatories shall be prefixed a concise statement of the subjects on which a discovery is sought and he shall deliver a copy of such interrogatories to the plaintiff or his solicitor and such plaintiff shall on oath answer such interrogatories and the practice with reference to excepting to answers

15 for insufficiency or for scandal shall extend to answers put in to such interrogatories Provided that in determining the materiality or relevancy of any such answer or of any exception thereto the Court shall have regard to the statements contained in the statement of claim and in the statement of defence thereto by the defendant exhibiting

20 such interrogatories Provided also that a defendant if he shall think fit may instead of filing interrogatories for the examination of the plaintiff institute against him a suit for the purpose of discovery.

#### Exceptions.

25. Except in the case of answers to interrogatories the practice Exceptions for 25 of excepting to statements of defence for insufficiency and to state-impertinence. ments of claims statements of defence and other proceedings for impertinence is hereby abolished Provided that the Court may direct the costs occasioned by any impertinent matter introduced into any proceeding to be paid by the party introducing the same.

shall be allowed unless such notice has been given except where the omission to give it was in the opinion of the Master a saving of expense.

The Judge may in every case obtain the assistance of con-Assistance of veyancing counsel accountants merchants engineers actuaries or other scientific persons. 35 scientific persons the better to enable him to determine any matter at issue in any cause or proceeding and to act upon the certificate of any such person The allowance in respect of fees to such persons shall be regulated by the Master subject to an appeal to the Judge.

48. Any party in any cause or matter may by a subpoena ad oral evidence on 40 testificandum require the attendance of any witness before the Court or motions &c. Master or any person specially appointed for the purpose and examine such witness orally for the purpose of using his evidence upon any motion petition or other proceeding in like manner as such witness would be bound to attend and be examined with a view to the hearing of a cause.

51. No suit shall be open to objection on the ground that a Declarations of right. merely declaratory decree is sought thereby and the Court may make binding declarations of right without granting consequential relief. c 90—B

# Formal Defects or Irregularities.

52. No proceeding shall be invalidated by any formal defect or Formal defects not by any irregularity unless the Court shall be of opinion that substantial to invalidate injustice has been caused by such defect or irregularity and that such 5 injustice cannot be remedied by any order of the Court.

## Sale of Mortgaged Property.

53. Where any real or personal property is the subject of any Allowance to parties proceeding in Equity and the Court is satisfied that the same will be out of property in more than sufficient to answer all the claims thereon which ought to 50 be provided for in such proceeding the Court may at any time after the commencement of such proceeding allow to the parties interested therein or any of them the whole or part of the annual income of such real property or a part of such personal property or of the income thereof up to such time as the said Court shall direct and for that 55 purpose may make such orders as may appear expedient.

The practice of the Court with respect to injunctions for Injunctions to stay the stay of proceedings at law shall so far as the nature of the case proceedings at law. will admit be assimilated to the practice of the Court with respect to 5 special injunctions generally and such injunctions may be granted upon interlocutory applications supported by affidavit in like manner as

in the case of other special injunctions.

person against whom such injunction is sought is or is not in possession under any claim of title or otherwise or (if out of possession) does or does not claim a right to do the act sought to be restrained 20 under any colour of title and whether the estates claimed by both or

by either of the parties are legal or equitable.

59. No writ of injunction shall hereafter be issued or any No writ to be issued. docquet be signed or filed as at present but service upon any person of the decree or order directing such injunction or notice 25 thereof shall have the same effect as the issuing of a writ of injunction and signing and filing of a docquet and service of the writ upon such person and thereupon the plaintiff shall be entitled to all such remedies as he is entitled to under the present practice.

# Abatement of Suit.

Upon any suit becoming abated by death marriage or other-Simplifying proceedwise or defective by reason of some change or transmission of interest suit. 30 or liability it shall not be necessary to file any new or supplemental statement of claim in order to obtain the usual order to revive such suit or the usual decree or order to carry on the proceedings but an 35 order to the effect of the usual order to revive or of the usual supplemental decree may be obtained as of course upon an allega-tion of the abatement of such suit or of the same having become defective and of the change or transmission of interest or liability and an order so obtained when served upon the party or parties who 40 according to the present practice would be defendant or defendants to a bill of revivor or supplemental bill shall from the time of service be binding on such party or parties in the same manner as if such order had been regularly obtained according to the existing practice and such party or parties shall thenceforth become a party or 45 parties to the suit and be bound to enter an appearance thereto as if he or they had been duly served with process to appear to such a bill duly filed against him Provided that the party or parties so served may within such time after service as shall be prescribed by any general rule in that behalf apply to the Court to discharge such order 50 on any ground which would have been open to him on a bill of revivor or supplemental bill stating the previous proceedings in the suit and the alleged change or transmission of interest or liability and praying the usual relief consequent thereon Provided also that if any party so served is under disability other than coverture such order

55 shall be of no effect as against such party until a guardian ad litem shall have been appointed for such party and such time shall have elapsed thereafter as shall be prescribed by any general rule.

It shall not under any circumstances be necessary for a Regulations as to 30 respondent to give notice of motion by way of cross appeal but if cross appeals. a respondent intends upon the hearing of the appeal to contend that the decision of the Court below should be varied or altered he shall within such time as may be prescribed by any general rule or by special order give notice of such intention to any parties who may be affected 35 by such contention The omission to give such notice shall not

diminish the powers by this Act conferred upon the full Court but may in the discretion of the Court be ground for an adjournment of the appeal or for a special order as to costs.
