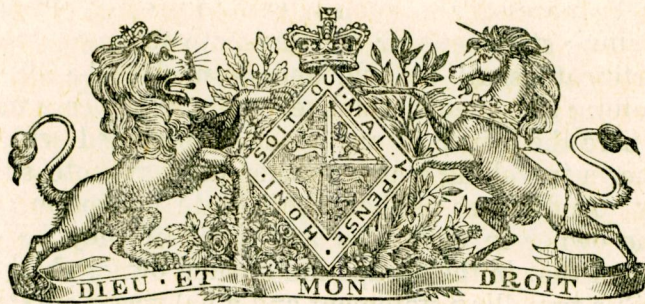

WHEREAS it is expedient to amend the "Diseases in Sheep Act Preamble. of 1866" and the "Diseases in Sheep Acts Amendment Act of 1878" and the "Registration of Brands Act of 1866" Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

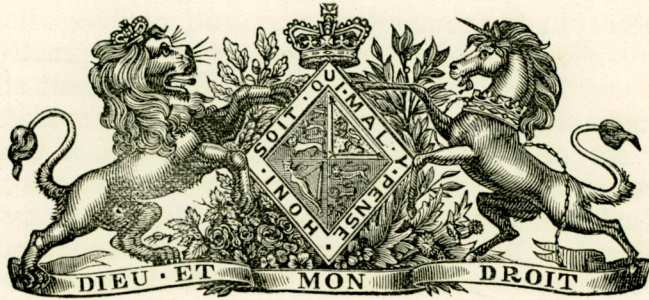

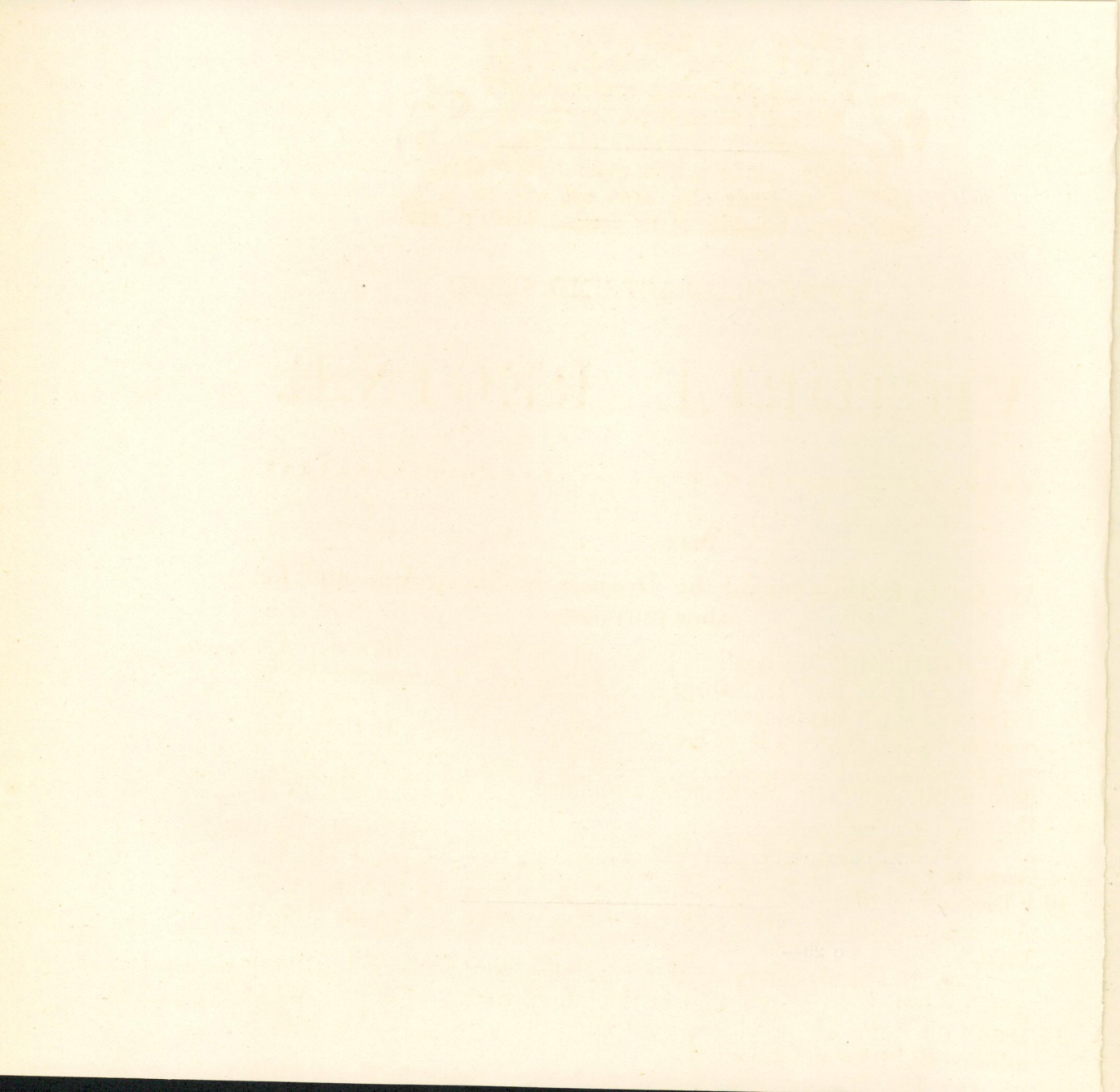

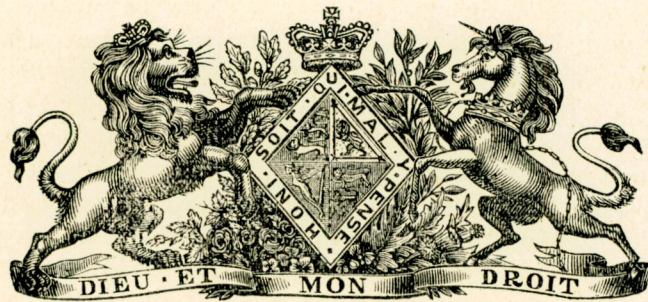
