An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Years 1882 and 1883. [Assented to, 29th January, 1883.]

WHEREAS we Your Majesty's most dutiful and loyal subjects Preamble the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the sum of Nine hundred and ninety-one thousand pounds that is to say—

The sum of Four hundred and eight thousand pounds being the sum required to defray the expenses of the various Departments and Services of the Colony from the first to the thirty-first day of January one thousand eight hundred and eighty-three And

The sum of Five hundred and eighty-three thousand pounds for the Services set forth in the Schedule hereto annexed

And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—


