An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of the Year 1884. [Assented to, 22nd May, 1884.]

THEREAS we Your Majesty's most dutiful and loyal subjects Preamble. the Members of the Legislative Assembly of New South Wales in Parliament assembled have resolved to grant to Your Majesty the

sum of Five hundred and ninety-five thousand pounds that is to say— The sum of Four hundred and thirty thousand pounds being the sum required to defray the expenses of the various Depart-ments and Services of the Colony for the month of May or following month of the year one thousand eight hundred and eighty-four And

The sum of One hundred and sixty-five thousand pounds for the Services set forth in the Schedule hereto annexed

And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the

The Treasurer shall issue and pay the said sum for the Services aforesaid in such manner and in such proportions as the Governor by Warrants or Orders in writing under his hand and directed to the said Treasurer shall from time to time order and direct And the payments so to be made shall be charged upon and payable out of the Consolidated Revenue Fund of the Colony. 3. The Treasurer shall in his accounts from time to time be
