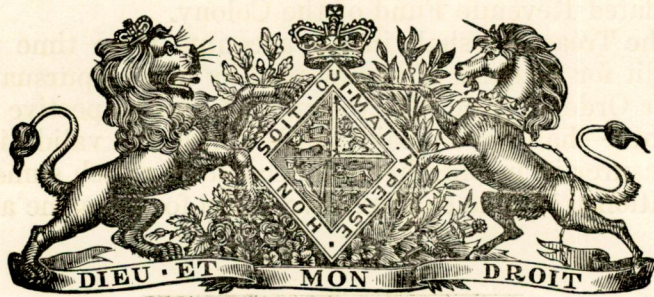

An Act to apply certain Sums out of the Consolidated Revenue Fund of New South Wales towards the Services of 1884 and previous Years. [Assented to, 28th August, 1884.]

**W**HEREAS we Your Majesty's most dutiful and loyal subjects Preamble.  
the Members of the Legislative Assembly of New South Wales  
in Parliament assembled have resolved to grant to Your Majesty the  
sum of Seven hundred and forty thousand pounds that is to say—

The sum of Four hundred and thirty thousand pounds being the  
sum required to defray the expenses of the various Depart-  
ments and Services of the Colony for the month of August  
or following month of the year one thousand eight hundred  
and eighty-four And

The sum of Three hundred and ten thousand pounds for the Services  
set forth in the Schedule hereto annexed

And whereas we desire to make good out of the Consolidated Revenue Fund of New South Wales the sum so granted to Her Majesty Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled and by the authority of the same as follows:—

1. Out of the Consolidated Revenue Fund of New South Wales £740,000 may be issued out of the Consolidated Revenue Fund.

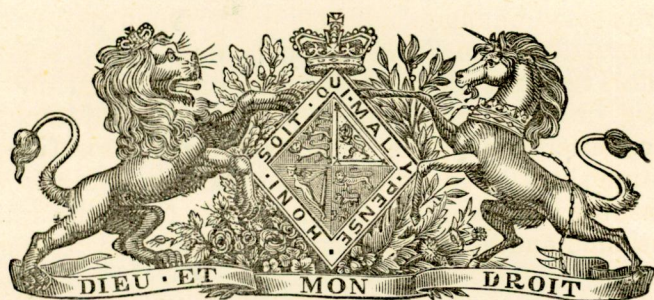
